1.) Will the furniture remain in the areas of work?

Response: The contractor is required to provide protection for furniture, all finishes and all equipment located in these areas.

2.) What is the deck height? Total clearance from ceiling to the bottom of beam?

Response: Bidders may investigate the site conditions at additional site walks scheduled on Monday 1/25/21 at 9:00 am or 10:00 am The ceiling clearance is approximately 36" to 38".

3.) Are we to demo the existing wet pipe?

Response: Yes, the bid documents require the existing wet pipe in the area of work to be removed.

4.) What is the condition under the raised floor?

Response: Bidders may investigate the site conditions at additional site walks scheduled on Monday 1/25/21 at 9:00 am or 10:00 am.

5.) Are these area critical areas?

Response: All areas of the Sheriff's Office are critical areas. All work areas are occupied and will remain in operation during the sprinkler and fire alarm installations. See Line 16 below for further clarification.

- 6.) To clarify the only access to the area of work will be the front entry doors. This building does not have a truck dock.
- 7.) To clarify this project requires a full time escort by Collin County Sheriff's Office. See Line 16 below for further clarification.
- 8.) Ask Facilities Maintenance about the annunciator fire alarm panel inside room D1614.

Response: The fire alarm panel inside the room has no impact on the scope of work for this project.

9.) Is the as built available for the 2017 sprinkler system renovation?

10.) What are the type sprinkler heads?

Response: See specification Section 21 1313 AUTOMATIC FIRE SPRINKLER SYSTEM section 2.03 SPRINKLERS.

- 11.) To clarify the contractor is responsible for permitting the project with the City of McKinney. Contractor must follow City of McKinney fire sprinkler and fire alarm requirements.
- 12.) Will room D1614 have carpet installed before the project starts?

Response: Yes, the room will have carpet installed. Provide labor to remove and reinstall the carpet tiles as required. Reminder: Contractor must provide protection for all finishes, furniture and equipment located in rooms D1613 and D1614.

13.) Will Collin County consider using a double interlock valve?

Response: Refer to the plans and specifications for pre-action valve replacement.

14.) Clarify the work times are 8:00-5:00, Monday through Friday.

Response: The work schedule is Monday through Friday 8:00 am to 5:00 pm. Any after hours and weekends must be approved two weeks in advance by the Sheriff's Office.

15.) Do the existing fire alarm devices in rooms D1613 and D1614 require demo?

Response: Yes, demo the existing fire alarm devices in rooms D1613 and D1614. Remove the devices, wiring and remove from the Edwards EST fire alarm programming.

- 16.) Contractor performing the sprinkler piping renovations will be allowed seven (7) working days to work inside the Child Abuse Task Force room (D1614) with no employees occupying the space. Employees will be moved to a secondary location for the safety of the employees with the following stipulations.
 - a.) Contractor shall provide a fourteen (14) day notice before starting work in room D1614.
 - b.) No work is allowed inside room D1614 in the month of March, 2021.
 - c.) There must be a Sheriff's Officer with the contractor while working inside room D1614 at all times. (This is included in the bid document's project specifications.)
