TO:

1.1.3 Maintain cafeteria serving and dining spaces in a clean, orderly, and healthy condition including small wares, firm owned/rented kitchen equipment, and County owned kitchen equipment.

EXHIBIT B: RESPONSIBILITIES OF COUNTY

ADD:

- 7. County will be financially responsible for maintaining maintenance agreements for all County owned kitchen equipment.
- 8. County will maintain County owned kitchen equipment (see Attachment A inventory)
