Judge Hill called to order the meeting of the Collin County Commissioners Court at 1:30 p.m. and recessed the meeting at 2:33 p.m. The meeting was reconvened at 2:33 p.m. and immediately recessed into Executive Session. Judge Hill reconvened Commissioners Court at 2:41 p.m. and adjourned the meeting at 2:41 p.m.

President Hill called to order the meeting of the Collin County Health Care Foundation at 2:33 p.m. and adjourned the meeting at 2:33 p.m.

2. Public Comments.

LaChay Patrice greeted the Court and said she is the sister of Marvin Scott III. Ms. Patrice said Marvin was murdered Sunday, March 14, 2021, inside the Collin County Jail, and the family was notified by text message the following day. Ms. Patrice said she blames Collin County collectively, from the Allen PD (Police Department) to the Allen Presbyterian Hospital and ultimately the Collin County Detention Facility. Marvin should have been evaluated for at least 24 hours before being considered for custody. Anytime Marvin had encountered law enforcement in the past, he would automatically be sent to a behavioral facility. The facility would keep him for at least two weeks in order to stabilize him and ensure the medications prescribed were working. Marvin should never have gone to jail. The Allen PD knew he needed to be at a behavioral center, and instead of getting him help, they helped him to death. Marvin needed to be a patient and not an inmate. Ms. Patrice said she should be picking up her brother from a behavioral center not picking out his casket. The Allen PD, the doctor at Allen Presbyterian Hospital, the Collin County Jail and Collin County have all failed Marvin tremendously. For a patient suffering from a mental health crisis, the methods used to restrain Marvin were uncalled for, inhumane and disgusting.

Tamara Johnson, McKinney, read an excerpt from the Psychological Hook by Doctor Misty Hook.

Amy Toole, Farmersville, said three weeks ago Marvin Scott III died in the Collin County Detention Facility. He was in custody for less than 24 hours before he died at the hands of law enforcement officers. His death is a result of police mistreatment, excessive force and inhumane action. Seven officers have been fired, and it is not enough that these officers nearly lost their jobs while the Scott family is mourning the death of their son and brother. The officers responsible for Marvin's death should be arrested and held accountable in a court of law. The video footage of the arrest and detainment should be released. The

treatment of Marvin is indicative of larger issues within the Collin County justice system. Changes must be made, and mental health services should be made widely available. Restraining measures such as spit masks, physical force, and pepper spray need to be severely limited or prohibited. Collin County claims its mission is to deliver services including justice and public safety. The death of Marvin Scott III is the antithesis of this mission. The community deserves better than what the County has delivered. Marvin's family deserves more than a few cops losing their jobs.

Michael Chyobotov, Plano, spoke on behalf of Susan Miller who couldn't be present. Marvin Scott III should be here to tell you his story, and he should have been able to spend the past holiday weekend with his family. Instead, he was murdered for having a mental health crisis and a joint by those we pay to protect us. Though I never had the honor of meeting Marvin, I have gotten to know his family. I've seen the strength they display as they fight for justice. I am here to amplify their voices and to stand beside them as we collectively demand more from our elected officials and our police force. We are here to ensure the appropriate resources are in place to help the next family and to prevent this atrocious act of cruelty from happening again.

Alejandra Bernal, Melissa, said it has been three weeks since Marvin Scott III was murdered by the Collin County police, and justice has not been served. The officers involved have not been arrested, their names have not been disclosed, and the video tapes have not been released. I have seen the family in agonizing pain every night since and cannot imagine the pain they are enduring after losing Marvin. They are not able to mourn Marvin's death because every waking moment they are fighting for the basic transparency and justice that should be expected of the police. This is not the first instance where law enforcement has failed people of color or people with mental illnesses. This will not be the last incident if change is not implemented. Marvin is the symbol of the unjust system that plagues so many lives. Ms. Bernal asked the Court to allocate more funds to mental health programs and set a lower cap on police budgeting.

Judith Reiter, Richardson, said Collin County is her home and is a wonderful community to raise a family. The news of Marvin's death prompted her to attend the vigil to mourn with the family. Marvin Scott III was a son, a brother, an American citizen, and a victim who is dead. Marvin did not die peacefully of old age. He was murdered by a disease called police brutality, racism, ignorance about people of color, and mental illness. Ms. Reiter requested the release of the names of everyone involved, the video of his treatment in the police car, and the video of his treatment at the jail. All those involved in Marvin's murder should be held accountable. This will not bring Marvin back, but maybe this will not happen again in Collin County.

Elizabeth Michel, McKinney, demanded the arrest of the Collin County eight. There is more than enough probable cause to have these officers arrested, and the family deserves to know who they are. She also demanded the resignation of Sheriff Skinner. She demanded more resources for mental health services in Collin County. She demanded Collin County follow the lead of the Plano Police Department and

immediately order all police departments to no longer arrest anyone found with less than two ounces of marijuana. Her next demand was the release of the videos from the night of Marvin's death. Sheriff Skinner promised transparency, and the family deserves to see the video now. Her final demand was to end the practice of the medical examiner sending a text message to a family notifying them of a family member's death. This is not only inhumane, but you should all be embarrassed that this is the procedure. We will not go away, and we will ensure visitors to Collin County know how this was handled. We will ensure all tourist and corporations that want to move to Collin County know how this county treats families dealing with mental illness. We demand justice for Marvin Scott III.

Joshua Murray, Lavon, said the job of the Court is to accomplish the mission of Collin County. The mission is to deliver services including justice and public health. During the last meeting, Commissioner Fletcher said the Commissioners Court has done many good things, but quitting was not one of them. Mr. Murray said he disagrees with the Commissioner. The graphs on hospitalizations, infection rates, hospital capacity, ventilator capacity and the unemployment updates are all examples of things that the County, and specifically this Court, has quit on. The unemployment rate has been the highest for the past two weeks since June of 2020. Commissioner Fletcher also spoke about no parties being thrown which he assumed was in reference to his paraphrased descriptions of the Court patting each other on the back for doing just enough. The type of party he was referring to was when Commissioner Hale stated the County's vaccination rate is one of the best in the state without acknowledging the fact it has more to do with the demographics of our County than this Court's contribution. Mr. Murray asked what the County's plan is to continue vaccinating people. (Time: 1:58 p.m.)

5. AI-50062 Public Hearing – Consideration and any action for the issuance of a mass gathering permit for Outlaw Nation Festival on April 17-18, 2021 at Myers Park & Event Center, Special Projects.

Judy Moody, Myers Park, said the park has received a request for a mass gathering permit for a new event. This is a two-day event with four musical artists per day, up to 125 artist vendors, ten food trucks, and events for kids. Ms. Moody said the mass gathering permit is for up to 5,000 attendees, but they are anticipating approximately 3,000 attendees. Judge Hill said the promotional material names the event the Outlaw Nation Festival, but the name listed in the documents presented to the Court is the Plano Music and Arts Festival. Ms. Moody said the event had been in Plano, but because of COVID-19 restrictions, they decided to solicit Myers Park. The event name is Outlaw Nation Plano Music and Arts Festival in McKinney.

Judge Hill called to order the public hearing at 2:04 p.m. and asked for comments. Hearing no comments, Judge Hill closed the public hearing at 2:04 p.m.

Both locations will run through April and will only administer home-based vaccinations. The Collin County Health Department has reached out to the local fire departments to determine if they have any home-based programs. Curative continues to operate at maximum capacity, and they have an efficient process. The County is still waiting for the stimulus payment, and the ERAP (Emergency Renters Assistance Program) is being marketed statewide.

Curative is administering vaccines to citizens eighty years old and over without appointments. Judge Hill asked how will Collin County citizens continue to get the vaccine once the government entities stop administering it. Mr. Bilyeu said the expectation is for the private sector to take over. (Time: 2:14 p.m.)

Commissioner Fletcher said there may have been changes since the conference, but there was a discussion regarding broadband legislation. A resolution passed supporting the use of funds from the Recovery Act for digital broadband access readiness and development. There was a discussion on comprehensive election reform. SB21 bail reform is expanding the PRB (Personal Recognizance Bond). SB23, which is a defund-the-police bill, is targeted at Austin and was getting into local control.

There was also a discussion regarding taxpayer-funded lobbying. Commissioner Fletcher said she reached out to elected officials and staff to ask for their feedback regarding the associations. These associations are critical to our operation and how we do things in Collin County. There is broad shared knowledge when the County participates in these associations. Commissioner Fletcher handed out a document about the associations the County is a part of and the costs. There were different views about taxpayer-funded lobbying, and this is an issue on both sides. Associations help with shared knowledge, provide training, and keep track of hours that are constitutionally required.

Commissioner Hale said, it is clear no matter what the subject, somebody's taxpayer money is being used for lobbying. There is no doubt these organizations are of benefit, but there is a difference between educational advice and their doing the job we were elected to do. (Time: 2:32 p.m.)






