 - 2. Each attendee will have a wristband, we will have only the amount of wristbands for the number attendees available.
 - 3. The limit at any one time is 5000 per spacing allowances.
 - 4. The admission and exit area will have 2 taking admissions at all times to count attendees as they enter the park and the exit area will deduct number of people in the park off as they exit.
 - 5. The crowd brings their own chairs and picnic blankets for seating. We do not provide crowd seating.
 - 6. Laser Tag is played in the great outdoors, the company sets up the course outside in a 50x 50 open air area, no tent or power is required.
 - 7. We expect less buy have planned for 125 artists to be in 10x10 tents, if anyone has a 10x20 they will be required to have a tent permit. Please advise if fire extinguishers are required for all vendors.
 - 8. The GO TEXAN are will have 50 10x10 tents.
 - 9. The aisle distance between each vendor and parking area is a minimum of 24feet.
 - 10. Food trucks are staged at the opposite end of the Festival area. We are still in the process of accepting food applications and will close this out in the 10 to 14 days. Each truck is spaced approximately 6 feet apart and trash cans are placed for the collection of trash. If they are not utilizing a truck/trailer mobile unit they are required to notifly the Collins County Health Department of all of the cooking and structure being used on site. There will fryers, smokers, grills, and flat tops on site within each food truck/trailer. These vendors will be required to have the size fire extinguisher mandated for their type of cooking according to the Fire Codes. All food vendors must follow Collin County Health and Fire Codes.

changes. Please also note that an artist does not always list us on their website. If they have an event on Thursday or Friday night they are under contract to promote that event. We will be promoted after that said event ends and they start promoting being on site with us at Myers Park, McKinney TX. Some events fear if the artists promotes both of us at one time attendees will choose the weekend event over the Thursday or Friday event and they will lose ticket sales is what we have been told by the artist. They will feature and promote the McKinney event as soon as the prior event ends.

 - All food merchants will abide by Collin County Health and Environmental agency rules and regulations. Each Food Vendor individually will obtain a temporary food permit from Collin County. They are each required to have a functional fire extinguisher of the size required for their cooking requirements. Said Food Vendors are also required to clean their area before, during and after the event comes to a
 - Porta Toilets and Portable handwashing will be accessible to all attendees 5 distinctly labeled Mens Porta Toilets
 - 15 distinctly labeled Womens Porta Toilets
 - 4 distinctly labeled Handicap Accessible Porta Toilets
 - 6 double sided sinks
 - Or these numbers will change as the Collin County Health Department directs/instructs. We will follow the code for Collin County
 - These receptacles will be serviced on Saturday evening and removed by noon on
 - Outlaw Nation Charities will rent dozens of large trash cans that are placed throughout the area and have a clean up crew on site that keeps trash off the ground and empties the trash bins replacing with fresh bags during the event. All trash is taken to a dumpster rented by Outlaw Nation Charities and placed on site during the event. The dumpster is removed after our clean up crew makes a final walk through on Monday morning. If needed the dumpster is serviced and emptied on Saturday evening. Our on site crew will guarantee that grounds are clean during and upon exit of the grounds of Myers Park, McKinney TX., on Monday
