## GENERAL DISCUSSION

# 5. <u>AI-48410</u> COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said Curative has administered just over 38,000 doses of the vaccine since the beginning of their contract. Commissioner Fletcher asked if there were any doses the County has received that have not been administered since the beginning of this process. Mr. Bilyeu said the County receives 11,700 doses per week, and those are distributed between the City of Frisco and Curative who both administer the vaccines on the County's behalf. As a Public Health Department, we do not have a large nursing staff. We are an epidemiology department which means we do tracking and forecasting. The building and parking lot of the Health Department were not built to run thousands of vehicles through there each day. This is the reason the Court chose Curative to administer the vaccines to the public at no cost to the taxpayer. Commissioner Fletcher said, while the County has created partnerships with the cities and Curative, the limitations on the County's ability to deliver vaccines is strictly based on the fact that we have not received the vaccines from the State.

Judge Hill said, unlike Dallas County with Parkland Hospital, Collin County does not have a public hospital. The Judge asked Mr. Bilyeu if the Health Department knew early on that it would not be able to internally administer all of the vaccines, and if so, did the County make provisions for this. Mr. Bilyeu said we knew this which is why we partnered with the cities and brought in Curative. Curative has added more clinical staff as needed when doses have become available. Curative said they had the capacity to administer up to 6,000 doses per day. Therefore, the County repeatedly requested 42,000 doses per week from the State but never received that amount during any week. The County receives 11,700 per week. It would have been closer to 4,000 doses per week but, because we were able to partner and get a deep freezer, we received more doses of the Pfizer vaccine. We have not received the amount of doses we have requested, but we have received the amount the State has allocated to us. Judge Hill asked Mr. Bilyeu if the County has been a good steward of the doses it has received. Mr. Bilyeu said the County has been a good steward of the vaccine doses for every vial.

Commissioner Fletcher asked Mr. Bilyeu if, at any time, he has thrown a party for the work that has been done here in Collin County and celebrated having met all of our goals. Mr. Bilyeu said he has not. The Commissioner said it is disingenuous for anyone to state the County has thrown a party and celebrated that we have received all the vaccines that we wanted. We have and will continue to advocate for more vaccines.

Judge Hill said he is tremendously proud of the employees of Collin County in the Health Care, IT, Public Safety and Administration Departments who have rolled up their sleeves and added to their normal job duties to make and receive calls from those seeking guidance during this pandemic. He is proud of so

many employees who have gone above and beyond to serve this community. There have been no celebrations throughout COVID; there has only been response. He is also grateful for the other agencies like the Cities of McKinney, Allen, Wylie and Frisco, Baylor, Scott & White and Texas Health Resources Hospital who have all helped to get the vaccines distributed and administered. It has been a tremendous effort of which so many people can be proud.

Commissioner Hale said we are now at 45% of the vaccinatable public having received at least one dose. There is still a large number of those aged 16 to 50 who are not eligible yet to receive the vaccine. Of the largest seven counties in Texas, Collin County is first by approximately 5% to the nearest county which is Bexar. When compared to Dallas and Tarrant Counties, we are 7% to 8% ahead. Collin County is about 8% ahead of Denton County. Mr. Bilyeu said we still have a long way to go and will continue to provide these services with excellence.

Mr. Bilyeu referred to the NACo (National Association of Counties) legislative analysis of the \$200 million in federal funding that will come to Collin County and said we will need U.S. Treasury guidance because of the limited interpretations and how it is written. The form to actually request the funding has not come through yet. Regarding housing assistance, the demand is not as great in Collin County as it is in other counties, and the requests are being processed quickly. (Time: 1:51 p.m.)
