2. Public Comments.

Joshua Murray, Lavon, said he came to speak out about the MUD (Municipal Utility District) listed on today's agenda. He expressed his displeasure with MUDs and wanted clarification about what cities MUD developments are comparable to. Mr. Murray said he looked at Texas cities with weak mayors and strong mayors and found no correlation. He said a MUD closely resembles a Russian city as in developers have the power to set the costs for the MUD without any restrictions from government officials or a competitive

bidding process to protect future taxpayers. Mr. Murray claimed MUDs are slush funds to take people's money during development. Once established, these funds become decades of job security for middlemen appointed by the MUD to maintain the district.

Judge Hill stated this item is on the Court's agenda, and Mr. Murray might be confused about the item. Judge Hill said this is not an item to approve a MUD. Collin County has already taken a position on MUD applications and currently opposes all of them. Judge Hill said the item on the agenda is for a plat within an established MUD.

Chris Pruitt, Pattillo, Brown, & Hill, said the County has received a Certificate of Achievement Award for

Excellence in Financial Reporting given out by the government. Mr. Pruitt mentioned the County has

received this award for a few years now. Mr. Pruitt said the responsibility lies with the County's

management for the financial segments, and his responsibility is to express an opinion on the financials.

These opinions are stated in the document attached to this court order. Mr. Pruitt explained his opinions

are unmodified and clean which means a third party can rely upon the financial statements being free of

mistakes. The general fund and unassigned funds are both very healthy. Mr. Pruitt pointed out, in the

general fund, the County received more money than anticipated and spent less than anticipated.

Therefore, the budget is strong for the year. Mr. Pruitt also said the last part of the report is the statistical

section which is unaudited because it is primarily ten years of trend data. However, the audit was only

performed for this year, and therefore did not have enough data to support a true audit of this section. A

10. AI-48410 COVID-19 Update, Administrative Services.

Bill Bilyeu, County Administrator, said he did not have a lot to report this week regarding COVID-19 and said the court should consider whether to continue this update. Mr. Bilyeu said it is becoming difficult to fill the available vaccination appointment slots. As of this morning, there were 780 appointments still available for today and, as the hours go by, these appointments expire without being filled. Tim Wyatt, Public Information Officer, did a press release Friday and today about the availability of shots. As of this afternoon, there are 200 appointments still available for today, and 4,700 available for the rest of the week.

Judge Hill said there has been some discussion that Collin County Health Services has not received additional vaccine doses from the State and asked Mr. Bilyeu why. Mr. Bilyeu said the County has enough doses to last the next few weeks sitting in inventory. He also stated the health department specifically did not request any new doses.

Judge Hill asked, if knowing Collin County had 4,600 available appointments, would it have been responsible for the County to request another 11,000 doses we could not use. Mr. Bilyeu said it would not have been responsible especially if there are counties that need the doses. Over 49% of the Collin County population over 16 years old has had at least one shot, and the demand for shots has decreased. Mr. Bilyeu said he is confident the State would give Collin County additional doses if needed.

Commissioner Hale said, of the top six counties, Collin County is at roughly 54% of people having received their first dose. The Commissioner said, as we approach the 60% and 70% marks, we are getting closer to herd immunity. (Time: 1:55 p.m.)

11. AI-49828 87th Legislative Agenda for 2021, Commissioners Court.

Judge Hill said the bill opposing all political lobbying funded by taxpayers was passed out to everyone. Last week, Commissioners Court voted to adopt a resolution supporting SB 234 and HB 749 as well as another resolution supporting the committee substitute for SB 10. Judge Hill also stated, because of the comments brought by Commissioner Fletcher last week, there is a new resolution stating they resolved that the Commissioners Court opposes taxpayer-funded lobbying by all political subdivisions and further resolved that the Commissioners Court holds that legislation prohibiting taxpayer-funded lobbying should apply equally to all political subdivisions.

Commissioner Hale said the committee substitute was already accepted, and the bill has already been voted on and gone through three readings. The Commissioner asked Judge Hill if he would consider the committee substitute to be SB 10 as amended and approved by the Senate. Judge Hill stated he took Hale's point, but since these are two different bills with significantly different language, he does not want to leave
