

- 1) 1 page of written text.
 - a. Due to dramatic price fluctuations in low-rise foam adhesives, at the contractor's option, the following alternate system to that specified in Section 07 54 19 is acceptable:
 - PVC membrane fully adhered over 1/4" DensDeck Prime, mechanically attached (gang fastened) through both layers of rigid insulation to LoadMaster Deck. Rigid insulation thickness is 4.5 inches.
 - b. All other aspects of the project are to remain unchanged.
