High-Density Loadmaster Duraflex Mineral Board: Fire resistant, weather resistant, fiberglass reinforced mineral core board with a minimum density of 48 lbs./cf. and a minimum compressive strength of 400 psi. Dimensions shall be 1/2 inch thick x 4 ft x 12'-6 in. The long edges of the board shall have a V-Type tongue and groove configuration with the ends being square cut. Guide markings shall be clearly printed on the top surface of each board to facilitate the proper location of spacing of the screw fasteners along with the Loadmaster label.
- C. Rigid Insulation: U.L Rated, Isocyanurate foam-type rigid plastic insulation, having an Underwriters Laboratories Flame Spread Rating of 25 or less, 4 ft. x 8 ft. is size. Provide two separate layers with joints staggered in accordance with Loadmaster requirements.

2.03 ACCESSORIES:

- A. Fasteners for Metal Decking: 12-24 x 7/8 inch HWH Traxx 4 Loadmaster Screw Fasteners. Side lap connectors shall be Loadmaster Diaphragm Side Fasters Screw Fasteners.
