The spread of the delta variant has caused another spike in Corona Virus cases. There has also been an increase in mental health emergencies, and the maternal mortality rate has increased. These are all signs indicating the County needs to increase their investment into health care. We have the opportunity to develop a medical corridor fully equipped with hospitals, medical training intuitions, and research facilities. This medical corridor would create over 100,000 new jobs in Collin County. Ms. Omere urged the Court to really look at how health care can be expanded in Collin County in order to provide the health care needed for future generations. Judge Hill asked what is Ms. Omere's idea for creating 100,000 new jobs. Ms. Omere said, if the County is able to open a medical facility, it would create many jobs. The Judge asked if the County would be responsible for creating the jobs or building the medical facility.
