# Vaccine Data

Collin County has 336 separate COVID-19 vaccine providers registered through DSHS. Collin County healthcare providers have given 1,094,135 doses of COVID-19 vaccine.

# COVID-19 Vaccine Services

- Collin County Health Care Services (CCHCS) is currently offering the following COVID-19 vaccine services:
  - Provides COVID-19 vaccines by appointment or walk-in at the Immunizations Clinic located at 825 N. McDonald Street, Suite 145, McKinney, TX 75069
  - Provides mobile COVID-19 vaccinations
  - Acts as a vaccine distribution hub for Collin County healthcare providers
  - Assists local healthcare providers with the Texas Department of State Health Services (DSHS) vaccine provider registration and trains them on vaccine storage and handling procedures
  - Provides continuous training and education to existing vaccine providers throughout Collin County

- CCHCS medical staff will travel to any individual residence, long-term care facility, workplace, business, or organization within Collin County to provide COVID-19 vaccines.
- CCHCS staff will only travel to a location by invitation of the patient or owner.
- There is no minimum threshold for the number of vaccines given. CCHCS will provide a single dose of vaccine or hundreds.



# COVID-19 Vaccine Boosters

On July 8, 2021, the CDC and the FDA jointly released the following statement as it relates to COVID-19 vaccine booster doses:

“Americans who have been fully vaccinated do not need a booster shot at this time. FDA, CDC, and NIH are engaged in a science-based, rigorous process to consider whether or when a booster might be necessary... We are prepared for booster doses if and when the science demonstrates that they are needed.”

Collin County Health Care Services has developed preparedness plans for the possibility of a future COVID-19 vaccine booster.



# COVID-19 Vaccine Boosters

If a COVID-19 booster vaccine is determined to be needed by the FDA and CDC, there are two possible situations that may arise.

1. A third dose of an existing COVID-19 vaccine (or second dose in the case of Johnson and Johnson), is needed. There is currently sufficient vaccine supply of these existing vaccine formulations for every individual who wants a booster dose to receive one. In this scenario, patients should be able to visit their personal healthcare providers and pharmacies for the booster.
2. A new formulation of vaccine is needed for the booster. There is the expectation of supply shortages in this scenario, which will result in a period where this vaccine is unavailable followed by a time when it abruptly becomes available. Everyone who wishes to receive a booster will need to be vaccinated at that time. This scenario may be similar to the initial COVID-19 vaccine roll-out.



# Collin County's Plan

- CCHCS has held meetings and communicated with its stakeholders to identify and integrate plans across Collin County for possible future COVID-19 booster vaccinations. These have included:
  - City governments and first responder agencies
  - Hospitals
  - Private healthcare providers
- Collin County has hired new medical staff via DSHS COVID-19 vaccine grants to support the mobile vaccination team. These staff would be utilized to provide booster vaccines in addition to other CCHCS staff.



# Collin County's Plan

- Texas House Bill 797 passed, effective May 18<sup>th</sup>, 2021, which allows home health agencies to provide vaccines to their patients, patient's families, and their employees.
- CCHCS conducted a survey of long-term care facilities in Collin County. It was determined that the primary barrier to them providing vaccines to their own residents and employees was lack of vaccine storage. CCHCS has increased its vaccine storage capacity and developed a plan to store vaccines on behalf of these facilities. CCHCS will utilize staff and Medical Reserve Corps (MRC) volunteers to act as vaccine couriers to these locations.



# Collin County's Plan

- Collin County Health Care Services maintains a Medical Reserve Corps (MRC) volunteer program. The Collin County unit consists of 190 volunteers, 91 of which have medical licenses.
- These individuals have been utilized at COVID-19 vaccine clinics hosted at Collin County Health Care Services. These volunteers can be activated for future COVID-19 booster vaccine clinics or other vaccine operations, such as delivering vaccines to long-term care facilities.
