**INTERLOCAL AGREEMENT BETWEEN THE CITY OF PLANO, CITY OF MCKINNEY, CITY OF FRISCO, AND THE COLLIN COUNTY SHERIFF'S OFFICE OF COLLIN COUNTY, TEXAS FOR THE DISBURSEMENT OF THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) AWARD**

This Agreement is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2021, by and between the City of Plano, acting by and through its governing body, the City Council, hereinafter referred to as City of Plano; the City of McKinney, acting by and through its governing body, the City Council, hereinafter referred to as City of McKinney; the City of Frisco acting by and through its governing body, the City Council, hereinafter referred to as City of Frisco; and the Collin County Sheriff's Office, hereinafter referred to as CCSO, collectively (the "Parties" or each "Party").

**WHEREAS**, the Parties have previously agreed that Plano Police Department would serve as Fiscal Agent for the Edward Byrne Memorial Justice Assistance Grant Formula Award, (hereafter the "JAG Award"); and

**WHEREAS**, this Agreement is made under the authority of Public Law 109-162 (Jan 5, 2006) Title XI—Department of Justice Reauthorization, Subtitle B—Improving the Department of Justice's Grant Programs, Chapter 1—Assisting Law Enforcement and Criminal Justice Agencies, Sec. 1111, Merger of Byrne Grant Program and Local Law Enforcement Block Grant Program; and

**WHEREAS**, the governing body of each Party, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

**WHEREAS**, the governing body of each Party finds that the performance of this Agreement is in the best interests of the Parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

**WHEREAS**, the Parties believe it to be in their best interests to reallocate the JAG Award funds.

**NOW THEREFORE**, the Parties agree as follows:

1. City of Plano agrees to forward to CCSO a total of **\$17,121.00** of the JAG Award funds which will be used by CCSO to purchase specialized equipment and training for hostage negotiations.
2. City of Plano agrees to forward to the City of McKinney a total of **\$16,675.00** of the JAG Award funds which will be used by the City of McKinney to purchase Police bicycles to enable the community officers to better patrol neighborhoods, police special events, and conduct other police related activities.-

3. City of Plano agrees to forward to the City of Frisco a total of **\$9,920.00** of the JAG Award funds which will be used by the City of Frisco to purchase a Mission Darkness BlockBox Lab and two different types of digital forensic software programs to be used in the field of digital forensics, evidence extraction and collection.

4. City of Plano agrees to keep the remaining total of **\$24,770.00** of the JAG Award funds which will be used by the City of Plano to purchase laser eye protection for officers to wear while engaged in crowd control and civil disorder operations to protect their eyes from injury due to the increased use of lasers during these types of incidents.

5. Nothing in the performance of this Agreement shall impose any liability for claims against any of the Parties other than claims for which liability may be imposed by the Texas Tort Claims Act.

6. Each Party to this Agreement will be responsible for its own actions in providing services under this Agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

7. The Parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.


8. By entering into this Agreement, the Parties do not intend to create any obligations express or implied other than those set out herein.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT AND MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF PLANO, THE CITY OF MCKINNEY, THE CITY OF FRISCO AND COLLIN COUNTY FOR THE APPLICATION FOR AND ADMINISTRATION OF THE DEPARTMENT OF JUSTICE 2021 BYRNE JUSTICE ASSISTANCE GRANT, AND DESIGNATING THE CITY MANAGER, OR DESIGNEE, AS OFFICIAL REPRESENTATIVE OF THE CITY IN MATTERS RELATING TO THE PROGRAM

**WHEREAS**, the City Council of the City of McKinney, Texas, recognizes the need for the application for and acceptance of federal funds, allocated to the City of McKinney to assist the McKinney Police Department in enhancing public safety and reducing crime in the City of McKinney; and.

**WHEREAS**, the Justice Assistance Grant funds are allocated by the U.S. Department of Justice, to be shared between Collin County, the City of Plano, the City of Frisco and the City of McKinney to enhance public safety and reduce crime.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**



Section 2. **Action Requested:** Execute a Memorandum of Understanding and Interlocal Agreement between the City of Frisco and other Collin County Law Enforcement agencies regarding the application process of the Byrne Justice Assistance Grant (JAG) program award.

The City of Plano Police Department agrees to be the Fiscal Agent for the Edward Byrne Memorial Justice Assistance Grant Formula Award. The funds for this grant will be distributed as listed below and such distribution is based on application, population and crime rate. The Frisco Police Department funds (\$9,920) will be used for the purchase forensic software and computer storage for use by Criminal Investigators.
