On Monday, August 23, 2021, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Commissioner Fletcher led the Invocation.

Commissioner Webb led the Pledge of Allegiance.

Judge Hill led the Pledge of Allegiance to the Texas Flag.

Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. and recessed the meeting at 2:21 p.m. The meeting was reconvened at 2:22 p.m. and immediately recessed into Executive Session. The Judge reconvened the meeting at 3:56 p.m. and adjourned at 3:59 p.m.

President Hill called to order the meeting of the <u>Collin County Health Care Foundation</u> at 2:21 p.m. and adjourned the meeting at 2:22 p.m.

1. Public Comments.

Joshua Murray, Lavon, said he wanted to recognize Commissioner Fletcher, Commissioner Williams, and Commissioner Webb for what they invested in for the budget. Mr. Murray also listed consequences of not investing in the employees of the County, and how it costs more in the long run to taxpayers.

Robert Kamali, Lucas, said he is an internal medicine hospitalist and his obligation is to take care of all walks of life. He wanted to bring awareness to what is currently going on in our hospitals because of the COVID-19 variant surge. Mr. Kamali listed examples of ways healthcare workers are depleted of reserves emotionally and physically and detailed why vaccines are important.

Elizabeth Michel, McKinney, came to ask for a mask mandate in Collin County and listed personal reasons for why she believes this would be the best course of action for the Court.

Judge Hill said Governor Abbott's executive order states no governmental entity including counties, cities, school districts or public health authorities may require any person to wear a face covering or mandate a person to wear one. Judge Hill also said this Court is forbidden by executive order to issue a mask mandate.

Gita Setty, Prosper, said she is a board certified pediatrician who is serving in Collin County and has children attending the Prosper ISD (Independent School District). Ms. Setty urged the Court to implement standardized protocols for mitigating the spread of COVID-19 in schools in order to close the gaps between districts where school administrators are not enforcing rules.

Judy Dishong, Plano, said she would like to see a detailed budget outline of Collin County Healthcare Services and the Commissioners Court ethics code.

Donnie Baird, Sherman, said he is here to address the Court on behalf of Robert Sheridan. Mr. Baird asked the Court to remove the Magistrate Judge, Lisa Bronchetti, from the bench. He said the Magistrate Judge set the bail of Hunter Collins, a sexual predator, too low, and Mr. Collins is now hiding in a different state and free to solicit more young girls.

Miguel Palacios, Plano, said the Human Resources Director made a plea for the Court to incentivize County employees to get vaccinated, but she was ignored. Mr. Palacios said leaders need to lead instead of

Judge Hill telling people he is trying to protect people's liberty.

Scott Coleman, Wylie, said residents of Collin County have demanded better leadership for the COVID-

19 Delta Variant, and hospitals in Collin County are either close to or 100% full. Mr. Coleman asked the

Commissioners to encourage vaccinations and stand up for local entities who want the freedom to keep

our children safe.

Scarlett Cornwallis, Prosper, asked the Court for \$24 million for Prosper ISD to offer a virtual learning

option to students to mitigate COVID-19 case increases. (Time: 1:59 p.m.)

Dan Powers, Chief Operations Officer for Children's Advocacy Center of Collin County, said their core

services for abused children in Collin County are forensic interviews, family and support services,

counseling, and community education. Mr. Powers said his team successfully continued to provide services throughout last year during the pandemic but is concerned because child abuse reports decreased

40% last year. He believes this is due to children staying home and not having people such as teachers to

report signs of abuse. Mr. Powers also said internet crimes against children have gone up 147% in the past year because bad guys were trolling the internet for children since everyone was at home. During COVID, children's mental health has taken a toll with 1 in 5 children suffering from anxiety and 1 in 4 children suffering from depression. Due to projected population increases in Collin County, the Children's Advocacy Center ran a campaign to raise \$10 million to fund a second location in McKinney. Mr. Powers said the campaign was 100% funded, and the land has been purchased. The anticipated move-in date is this time next year.

Commissioner Fletcher asked Mr. Powers if an increase in reported abuse cases when kids go back to school is normal regardless of COVID. Mr. Powers said they used to see a decrease in cases in the summer, but now it is constant over the past five years. He thinks it is because professionals are educated now on the signs of abuse, and many more people can report it. (Time: 2:14 p.m.)

Commissioner Fletcher said there was a virtual meeting on August 19, 2021. The Senate passed 12 priorities in the first call and 15 in the second call for the Special Session. The two priorities not passed yet were the appropriations of ARPA (American Rescue Plan Act) and the restoration of Article 10 Senate funding. Commissioner Fletcher also said elections will require the presence of a Deputy Sheriff at collection locations as well as video monitoring. This will need to be included in county budgets. There is also concern about being able to obtain election judges if poll watchers are not properly trained and do not follow the law. HB241 is a forensic audit bill, and the CUC (Conference of Urban Counties) does not anticipate the bill going anywhere. SB6, the bail reform bill with a companion bill of HB12, was discussed as a substantial cost to counties in its present form. The CUC is currently developing estimates for counties. Redistricting was briefly discussed as 154 counties lost population within the past 10 years, and a redistricting session may happen in October. Commissioner Fletcher also said the election in May will probably be combined with the County primary or take place the first Tuesday in April due to issues with signature verification machines. (Time: 2:21 p.m.)
