Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. and recessed the meeting at 1:50 p.m. The meeting was reconvened at 2:10 p.m. Judge Hill recessed into Executive Session at 2:11 p.m. The Judge reconvened and adjourned the meeting at 2:42 p.m.

President Hill called to order the meeting of the <u>Collin County Health Care Foundation</u> at 1:50 p.m. and adjourned the meeting at 2:10 p.m.

### 1. Public Comments.

Miguel Palacios, Plano, said, when reviewing the budget, the Court needs to take into consideration the unique needs of rural areas. Mr. Palacios also said the budget should be fairly balanced to protect Collin County's individual and corporate constituents. He spoke about how the budget approval process works and he recommended the creation of a commission to review the Court's budget decisions.

Jim Bergerson, McKinney, said he is a current detention officer at the Collin County Jail. He spoke about the large number of open Detention Officer positions and how difficult it is to run a fully-functional jail with such a low number of staff. Mr. Bergerson asked the court to consider a solution to the high turnover rate and open positions whether that's implementing new recruiting programs, raising pay, or any other solution. He also asked the Court to consider support for the Sheriff's Office budget proposals this year as he believes Sheriff Skinner has the jail's best interests in mind.

Judge Hill said the Court has adopted many ideas over the years to recruit more Detention Officers at the jail and is open to any that are brought to the Court.

Judith Dishong, Plano, said she would like to speak to Public Health. She said she has concerns about access to public health by the indigent citizens of Collin County. Ms. Dishong said she has not seen much public health in Collin County or in Texas in general. She said she would like to see a study or commission to look at what is needed to address the health of the indigent population in Collin County.

Commissioner Fletcher said Collin County has a myriad of ways they help indigent citizens. We have participated in our federally-qualified health center startup in McKinney for the care of indigent citizens who are at and below 100% of the poverty level. Commissioner Hale said this program is State-mandated and is not an item that is up for consideration with the budget. Commissioner Williams said there is a program called Project Access to refer people for free healthcare.

Joshua Murray, Lavon, said the Collin County HR (Human Resources) Department produces reports specifically on Detention Officers and compares them to counties with different demographics to make

the County look better. Mr. Murray said the County can either reduce the standards required for employees or increase the salaries. Mr. Murray said the County has low standards of hiring when it comes to Detention Officers, and the pay needs to be increased to fill the open positions. Mr. Murray also said Judge Hill has failed the County in the past 12 months with his actions.

Iroghama Omere, Plano, said the residents of Collin County would like the Court to reduce unnecessary expenses in the departments that receive the most funding and allocate the money to expanding healthcare. Ms. Omere said there is a rising number of COVID-19 cases, and we need to dedicate resources to expanding healthcare in the County. Judge Hill asked Ms. Omere what the unnecessary spending is. Ms. Omere said it would be on each department to determine where they can conserve and find savings to put back into healthcare especially in rural areas where it is needed most. (Time: 1:48 p.m.)
