RE: FY 2022 General Liability Insurance Renewal

The county's current general liability coverage with USI (Intact, Chubb, and Global Aerospace) will expire on October 1, 2021.

The proposed policy renewal is \$697,547, an increase of approximately 48% over last year's premium of \$469,995. This increase in premium is the result of updated exposure information and the changes in the general liability market. The largest share of the premium increase is due to changes and updates in the law enforcement portion of the policy. This policy also includes increases in our retention for employment practices liability and law enforcement liability from \$50,000 to \$100,000 each.

I recommend we renew with USI (Intact, Chubb, and Global Aerospace) for the upcoming year. This includes policies with for general liability coverage, excess liability coverage, auto, professional liability, crime, terrorism, commercial general liability (Myers Park only) with Intact. This also includes policies for healthcare professional liability with Chubb, and drone coverage with Global Aerospace.

The new policy will be in effect from October 1, 2021 to September 30, 2022. The premium will be issued from account number 5501-03020-0018-41-30-0000-615905.
