On Monday, October 4, 2021, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

# COMMISSIONERS COURT BUSINESS:

# 1. Public Comments.

Kelly Karthik, Frisco, said Collin County's biggest projects using the CARES Act funds are with law enforcement and the healthcare department.

David Smith, Plano, said he is a former Plano City Council member and asked the Court to use the American Rescue Act funds to eliminate the pandemic, help businesses recover, and form a citizens' committee to make recommendations.

Alex Cornwallis, Prosper, said he urges the Commissioners to use the American Rescue Plan funds for projects to stop COVID-19. Mr. Cornwallis said his second request is for the Court to form a citizens' committee to hold public meetings and recommend projects for these funds.

Scott Coleman, Wylie, requested the formation of a public citizens' committee on the next Court agenda. Mr. Coleman also said no other businesses, city councils, or chambers of commerce have signaled approval for the projects the Court has planned for the American Rescue Plan funds.

Judy Dishong, Plano, said the County does not appear to have enough money to fund essential services including the jail. Ms. Dishong said she is tired of seeing local and state governments wasting money on lawsuits and election audits.

Cynthia Brugge, Fairview, said she ran for reelection as councilwomen in her town but lost by 18 votes and did not question the loss. Ms. Brugge also said part of the Commissioners' oath is to protect the Constitution and ensure the elections are secure.

Miguel Palacios, Plano, said a recount of votes in Collin County is a waste of time and taxpayer money.

Commissioner Fletcher said the Court did not pass a motion to have an election audit. The election audit is mandated by the Secretary of State and will be conducted in the top two Democratic and Republican counties. Commissioner Fletcher also said the Commissioners Court does not have the authority to override the State of Texas.

Judge Hill said Mr. Palacios' claim of taxpayer dollars being wasted on the election audit is false. Judge Hill reiterated Commissioner Fletcher's statement and said, if the State tells Collin County to do this, then the Court will participate and do it well.

Mark Brugge, Fairview, said there are too many whistleblowers for election voting machines to be considered safe and secure. Therefore we are vulnerable to having elections stolen. Mr. Brugge also said he wants to know if any COVID-related funds the County has received have limitations attached to them.

Joshua Murray, Lavon, said, compared to Dallas and Tarrant Counties, Collin County has come up with a bad COVID response plan and is not using funds like the Commissioners said they would. Mr. Murray also said he would like to see a public committee formed. (Time: 2:05 p.m.)
