RE: IFB 2018-227 90-Day Extension – Proposed 1.2% Price Increase

Dear Ms. Pease:

The Collin County business is important to us. In order to continue to deliver Ecolab world-class service and support, we are requesting a price adjustment on this agreement effective October 1, 2021. This is a result of overall rising costs for the products and services Ecolab extends; from manufacturing and transportation to employment costs and unprecedented tariff increases, Ecolab costs are steadily increasing.

As always, your agreement with us includes:

- Preventative maintenance
- 24/7 support and emergency service
- Contract support from Ecolab Global headquarters

Ecolab Inc. would like to extend our Collin County contract for 90-days. However, Ecolab is requesting a 1.2% price adjustment. Cost of goods have escalated more than we've seen in recent years. The Producer Price Index (PPI) for all commodities has increased 12.0% year on year; this includes cost of chemicals, labor costs, transportation costs and so much more. The PPI specific to chemical manufacturing has increased 6.8%. It's not been since 2012 that these costs have increased so greatly. Please see PPI Tables attached.
