Commissioner Webb said the RTC (Regional Transportation Council) was re-certified by the U.S. Department of Transportation and will continue to be eligible for federal planning funds. The Texas Transportation Commission made changes to the RTC's proposed ten-year plan, and approximately \$600

million was removed from a US 380 project. The change was done despite the RTC and TxDOT's (Texas Department of Transportation) request for the funds. The Spur 399 project is funded and set to begin in 2026. TxDOT plans for the entire US 380 corridor to be environmentally cleared by December 2022. The region may have funds that will need to be redistributed, and the RTC has put the US 380 project at the top of the list for these funds. (Time: 1:38 p.m.)
