**WHEREAS**, the City Council approves Collin County's amendment to the current Animal Shelter agreement, to include the following fee:

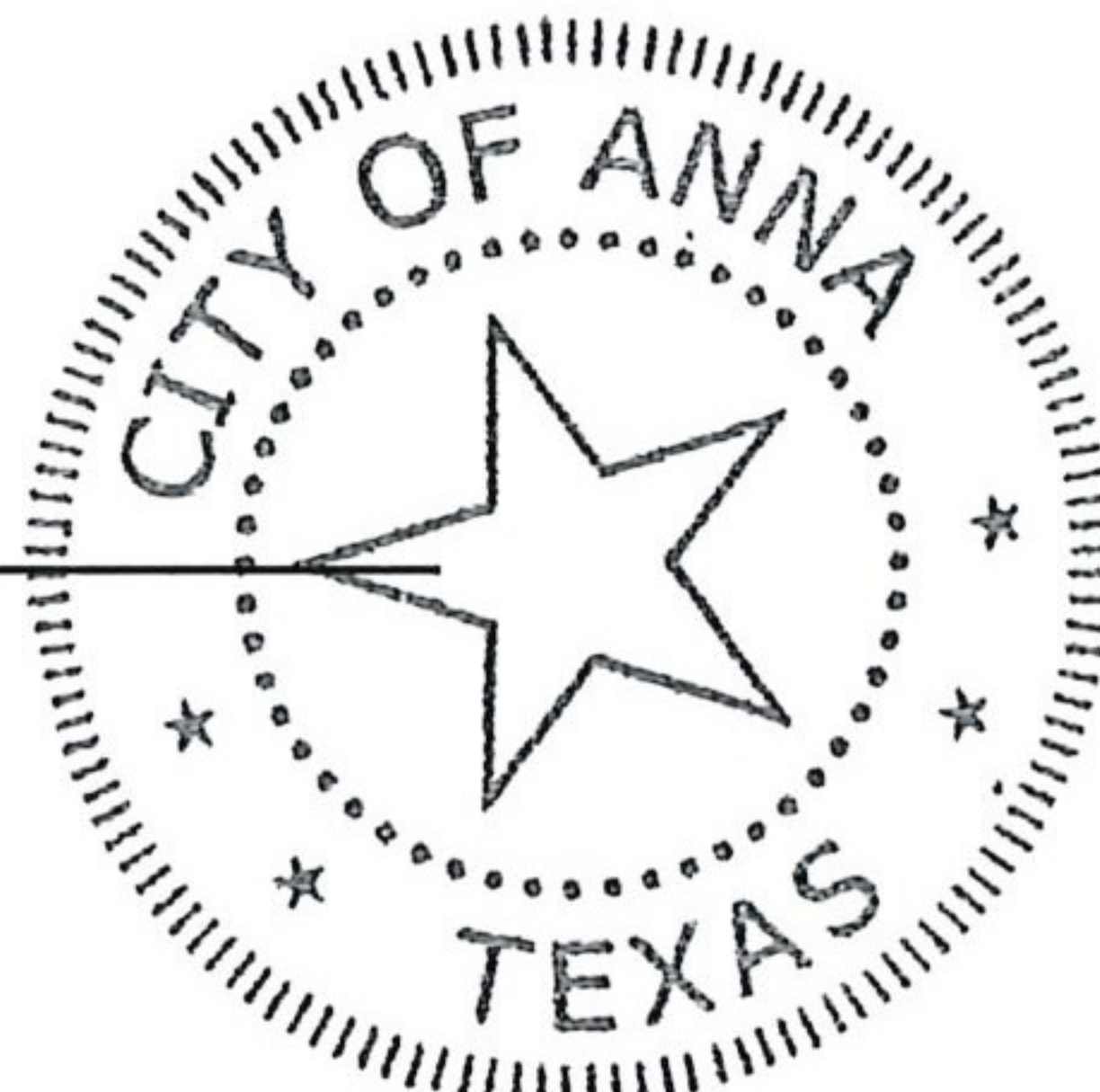
