The **Request for Applications ("RFA")** describes the purpose, funding opportunities for all grant categories, funding goals, grant program guidelines, standards for grant management, application process steps, required documents to submit an application, and approval process steps.

The **Grant Program Requirements & Terms and Conditions ("Program Requirements")** describes operational requirements and limitations for organizations executing an approved grant. Contract terms and conditions for state funding are included in this document.

The **Reimbursement Documentation Requirements ("RDR")** provide applicants with specific details of which documents are accepted as proof of cost incurred and demonstration of payment.

Award decisions will be made by the Commission in May 2022.
