X C. Cash drawer change fund counted agrees with General Ledger.  Comments: The change fund balance counted was \$302. The authorized change fund balance was \$300. This left a change fund overage of \$2.00.

<b>Recommendation:</b> All checks should be restrictively endorsed, receipted, and deposited immediately. The total change fund amount should reflect the Commissioners Court approved and documented change fund balance.
