Brian Pfahning - Representing the Turning Point Rape Crisis Center - Brian Pfahning is currently a reserve Sergeant with the Collin County Sheriff's Office and a full-time Registered Nurse in the Emergency Department and CVICU. Prior to becoming a nurse, Brian worked for the Plano Police Department. During his time at the Plano Police Department, Brian spent over 12 years working as a detective in a variety of units including the Crimes Against Persons Unit and Sex Crimes Unit. Brian retired from Plano Police Department in 2019 after deciding to pursue his other passion medicine. As the senior detective in the Sex Crimes unit, Brian assisted in the starting of Collin County's first and only free-standing forensic clinic located at The Turning Point, which is Collin County's Rape Crisis Center located in Plano, Texas.
