RE: FY 2022 General Liability Insurance - Additional Coverage

Collin County recently took armored services in-house and Risk Management confirmed that this type of work is not currently covered under our existing general liability policy. To reduce the county's risk in this matter, we are recommending adding additional coverage to our general liability policy for these services We received a proposed quote to add this line of coverage for \$9,593.25 annually.

The additional coverage will be in effect from the date Commissioner's Court approves the coverage to September 30, 2022. The premium will be issued from account number 5501-03020-0018-41-30-0000-615905.
