General Discussion

2. <u>AI-51229</u> CDC recommendation on vaccine eligibility, Health Care.

Taylor Burton, Health Care Services, gave an update on the COVID-19 vaccine response. The vaccine approval process was explained. Ms. Burton presented a chart to explain vaccine eligibility for Pfizer, Moderna, and Johnson & Johnson. People five years and older are eligible to get the Pfizer vaccine. Additional doses of the Pfizer or Moderna vaccines are recommended for moderately to severely immuno-compromised people. A booster dose is recommended for people who are at higher risk for COVID-19 exposure or severe illness. Booster doses can be any of the three vaccines and it doesn't need to be the same as the original dose received.

The Collin County website has a link with information on COVID-19 and vaccine locations. There is also an online system that can be used for scheduling vaccine appointments at the County Health Care Clinic. Collin County and the State also have a mobile vaccine option. Ms. Burton gave an overview of all the vaccine resources available.

A chart was presented comparing Collin County's COVID-19 vaccine data to other counties. Collin County has higher percentages of vaccinated populations compared to surrounding counties. The vaccine for children age five to eleven is being administered at the County Health Care Clinic. (Time: 3:18 p.m.)
