On Monday, January 24, 2022, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. and adjourned at 2:01 p.m.

President Hill called to order the meeting of the <u>Collin County Health Care Foundation</u> at 2:01 p.m. and adjourned the meeting at 2:01 p.m.

COMMISSIONERS COURT BUSINESS:

1. Public Comments.

Joshua Murray, Lavon, asked the Court if the County has plans to make any contributions to the metroplex's effort in responding to the Omicron variant. Neighboring counties have proactive information distribution, are assisting in testing, and have put in efforts to inform constituents of the benefits of the vaccine. Larger cities in the County with available resources have shown an effort to contribute. The State Department of Health and Human Services has also helped to combat disinformation and to contribute to this effort. County non-profit organizations are also actively doing something to help. Mr. Murray said Collin County has done nothing to help and asked the Court if there are plans to do anything.

Mr. Murray said the word liberty is a synonym for the word freedom. In politics, liberty is the state of being free from control or oppressive restrictions imposed by an authority on one's way of life. It is unfortunate, but it seems like this Court continues to fail to acknowledge the effects of this public health emergency and the way it has oppressed our way of life and restricted our liberty. He asked what the Court is going to do to protect our liberty. Is there a type of vaccine education the County could do, or is the Court going to continue to sit on the bench doing nothing. There is a desire by many constituents for the County to do its part and assist the metroplex in responding to this public health emergency.

Mr. Murray said the County is celebrating the groundbreaking for a detention facility that has no operational plan in place and asked if the Court has set budgetary guidelines so the Sheriff can properly plan.

Judge Hill asked Bill Bilyeu, County Administrator, if the County website still has information about vaccine availability and COVID-19 testing. Mr. Bilyeu said that information is on the website. The Judge asked Mr. Bilyeu to talk to Mr. Murray and ensure he knows all of the available resources.

Judge Hill said there was a comment made that there is no operational plan for the new detention facility and asked Jim Skinner, Sheriff, if he would like to speak on that. Sheriff Skinner said the department has been working on detailed plans for the new facility for the past two years. In fact, the Collin County Detention Office is working with the National Institute of Corrections to identify a mental health specialist to work on operational plans. Judge Hill thanked Sheriff Skinner. (Time: 1:36 p.m.)

GENERAL DISCUSSION

a. <u>AI-51418</u> Foreclosed property sale location, Justice of the Peace, Precinct 1.

Judge Hill said this item was held to give elected officials time to weigh in on this matter and asked if there was any additional information. Bill Bilyeu, County Administrator, said one response was that jury duty occurs every day and is not limited to Mondays. Many elected officials don't know what a foreclosure sale involves and couldn't give feedback.

Commissioner Hale asked what the parking constraints would be for parking at the courthouse compared to the administration building. Mr. Bilyeu said there is not much difference between the two locations. The administration building has a smaller parking lot but has never been at full capacity. However, when the courthouse is at full capacity, the parking lot does get full.

Commissioner Webb said he has not heard from any elected officials since the last discussion which indicates there is no opposition to moving the sale to the courthouse. From an attorney's perspective, having the postings and recordings all in the same building is very convenient. Dallas County does the sales on the courthouse footsteps and the recording can also be done in the same building. Commissioner Webb said he is neutral on this matter, and he is weighing Judge Raleeh's opposition versus the convenience for tax-payers.

Commissioner Fletcher said she agrees with Commissioner Webb and said she has heard opposition from the courthouse. A couple of judges have confirmed that jury selections are done throughout the week and are not limited to specific days. The Commissioner said she would like to keep the foreclosure sale at the

Administration Building. The sale could be moved further away from the front doors if it is causing an inconvenience to the JP's (Justice of the Peace) Office.

Commissioner Hale said he understands Judge Raleeh's concerns, but staff could work around those issues. The administrative campus will not be the same in the upcoming years as additional parking and buildings are created, and the sale can be rearranged in the next year or two. Commissioner Hale said he is not predisposed to moving the sale now. (Time: 1:43 p.m.)

Jim Skinner, Sheriff, said this item is for DWI (Driving While Intoxicated) units needed due to growth and the statistics on traffic-related incidents. The metrics indicate the County will have to concentrate on those items. As part of the upcoming budget, the Sheriff will request two additional deputies to work nothing but DWIs. Currently, there are only two deputies working traffic calls for 500 square miles. There were approximately 7,600 reckless driving calls last year. This year the County is on track for 740 DWI crashes. Over the past two years, there have been 112 people killed in fatal crashes. This is an issue that needs attention and a solution. Sheriff Skinner said, rather than asking for four units during the budget, he is asking for two now and will pay for them with money seized from drug cartels. These units are only to be driven during DWI enforcement because they will be equipped with panoramic cameras for evidence. On the days the SO (Sheriff's Office) is above minimum staffing, SFST (Standard Field Sobriety Test) qualified deputies will use the units to work DWIs.

Judge Hill said this item doesn't require a Court vote to approve, but it will require staffing. The Judge asked if these vehicles will be placed on the repair and replace list. These units will be Ford, and our maintenance department works on Fords which would solve the issue of maintenance. Commissioner Webb asked what were the Judge's thoughts on putting these units on the repair and replace list since the Sheriff will be asking for the officers during the budget session. Judge Hill said the default position of the Court is that the units will not be on there until they are actively placed on the list. The Sheriff has a full strategy for DWI, and placing the units on the list could be answered during budget. Commissioner Webb agreed. Commissioner Fletcher said she is supportive of this and thanked the Sheriff for focusing on this important public safety issue and a made a motion to approve. Judge Hill said a motion was not needed for this item. (Time: 1:48 p.m.)

Judge Hill said the Purchasing Department asked the Court to take a vote on the motion made earlier by Commissioner Fletcher. (Time: 2:00 p.m.)

d. AI-33858 Regional Transportation Council monthly update, Commissioner, Precinct 4.

Commissioner Webb said there is additional money coming to the state for transportation infrastructure. The RTC (Regional Transportation Council) adopted a policy stating 2022 will be a year of "doing". There are major projects involving millions of dollars that are likely not going to happen. As a result, there will be a reallocation of major monies throughout the state. The RTC will be doing everything possible to get as many projects ready for construction over the next three years including US 380. The goal is to be ready for construction by 2024. The region as a whole is pushing for US 380 to be environmentally cleared in order to move forward and turn it into a freeway. The Mobility 2045 Plan is being amended this spring, and part of the amendment will be to officially include US 380 for the first time. When US 380 is on the planned map, it will have a project code for TxDOT (Texas Department of Transportation) which will allow money to be officially allocated to the project.

DFW's (Dallas-Fort Worth) Metroplex population is projected to be 11.5 million by 2045. Collin County's population is projected to be 1.8 million by 2045. The jobs being created are greater than the number of people moving to the area. As people continue to move here, housing and transportation will continue to be a challenge. Over 50% of the growth will be outside one of the three transit providers, so transit models will have to be integrated. Tax revenues collected for 2020 were 8% above pre-COVID, and the amount of taxes is larger. Therefore, in terms of revenue, there will be extra money during the upcoming budget session. Commissioner Fletcher said, in the past, the estimated population for Collin County was 3.5 million by 2050 and asked if there was a reason the projection is more conservative now. Commissioner Webb said it is not a more conservative projection, and the 3.5 million projection is closer to the year 2060. Commissioner Hale asked if the US 380 project will be fully placed on the mobility plan. Commissioner Webb said the entire project will be on the plan, but there could be amendments. (Time: 1:59 p.m.)

NO ACTION

Judge Hill said the Court needed to revisit items b and c of the general discussion.

Bill Bilyeu, County Administrator, said there is a broken water line, and the City of McKinney has shut off the water at the administration building. They expect the water to be back on and running in less than an hour. (Time: 2:01 p.m.)
