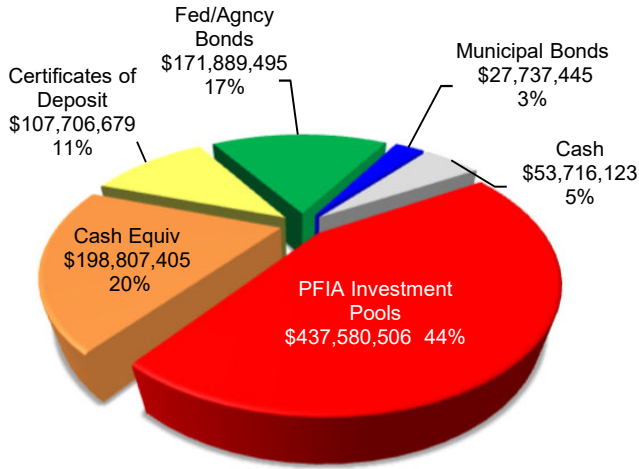

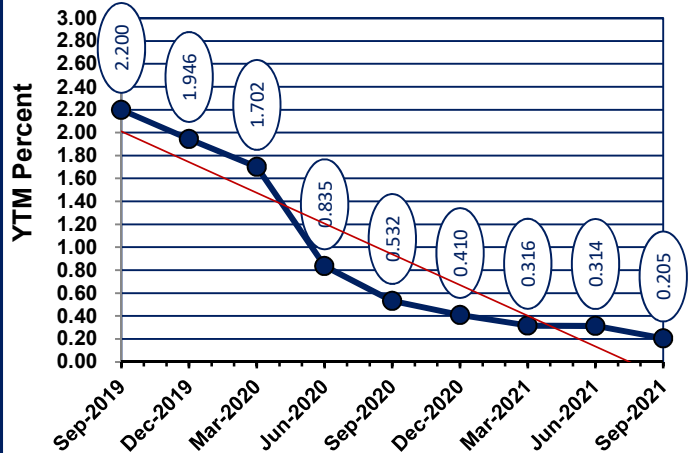

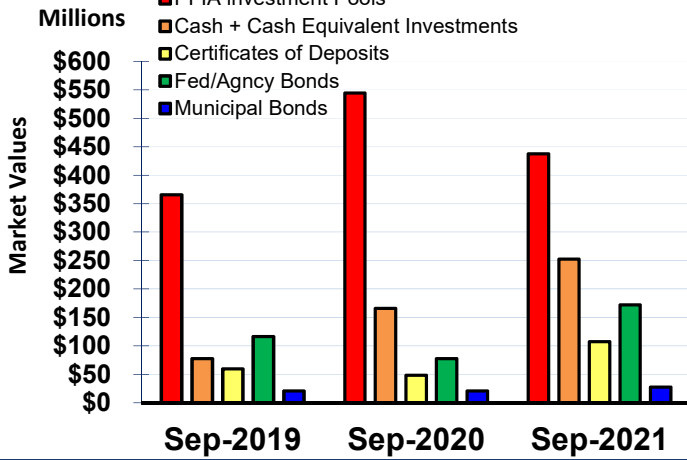
**Portfolio Composition by Type**



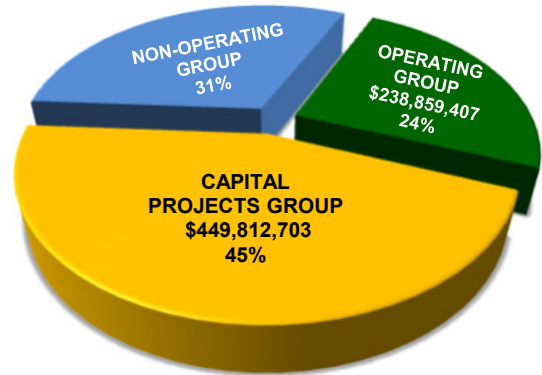
**Portfolio Weighted YTM 2 Year Trend**



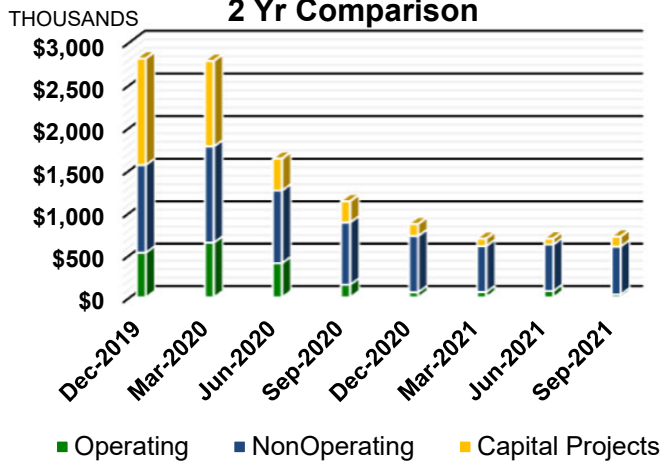
**Portfolio Position by Type 3 Yr Comparison**



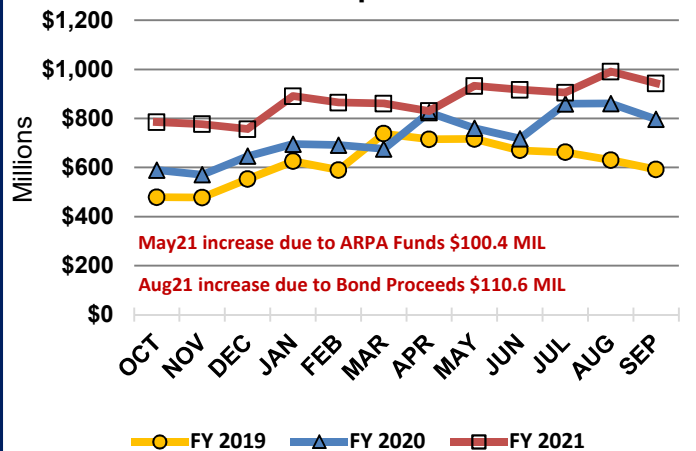
**Portfolio Composition by Investment Pool Group at Qtr End**

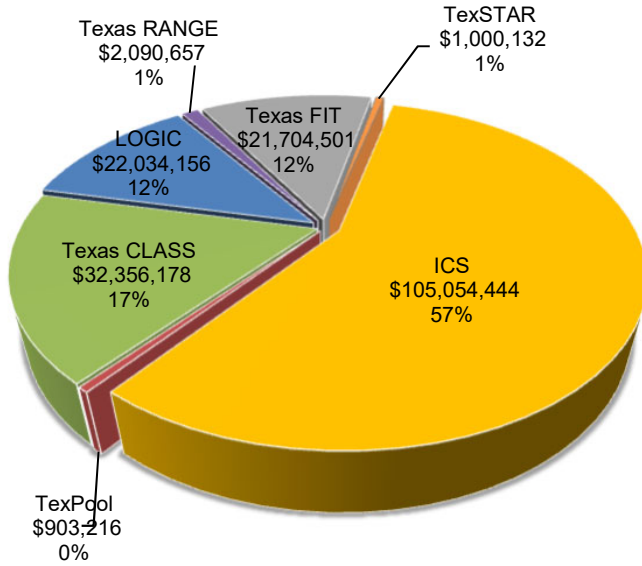

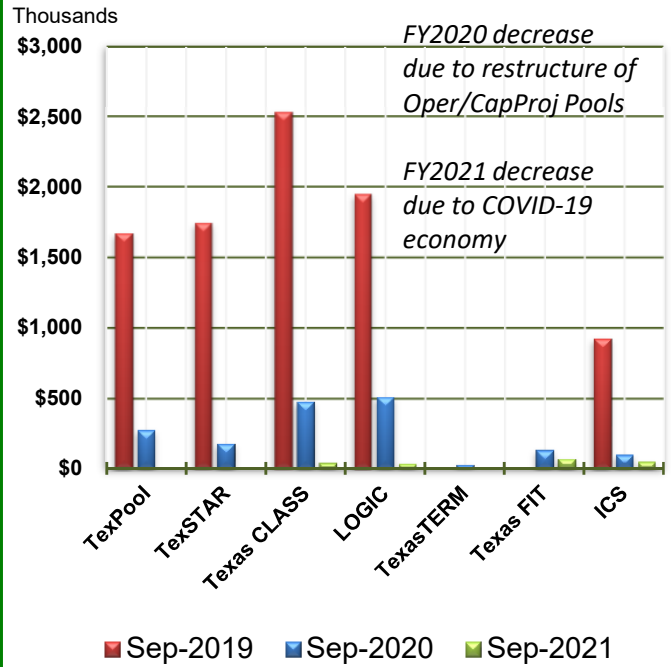

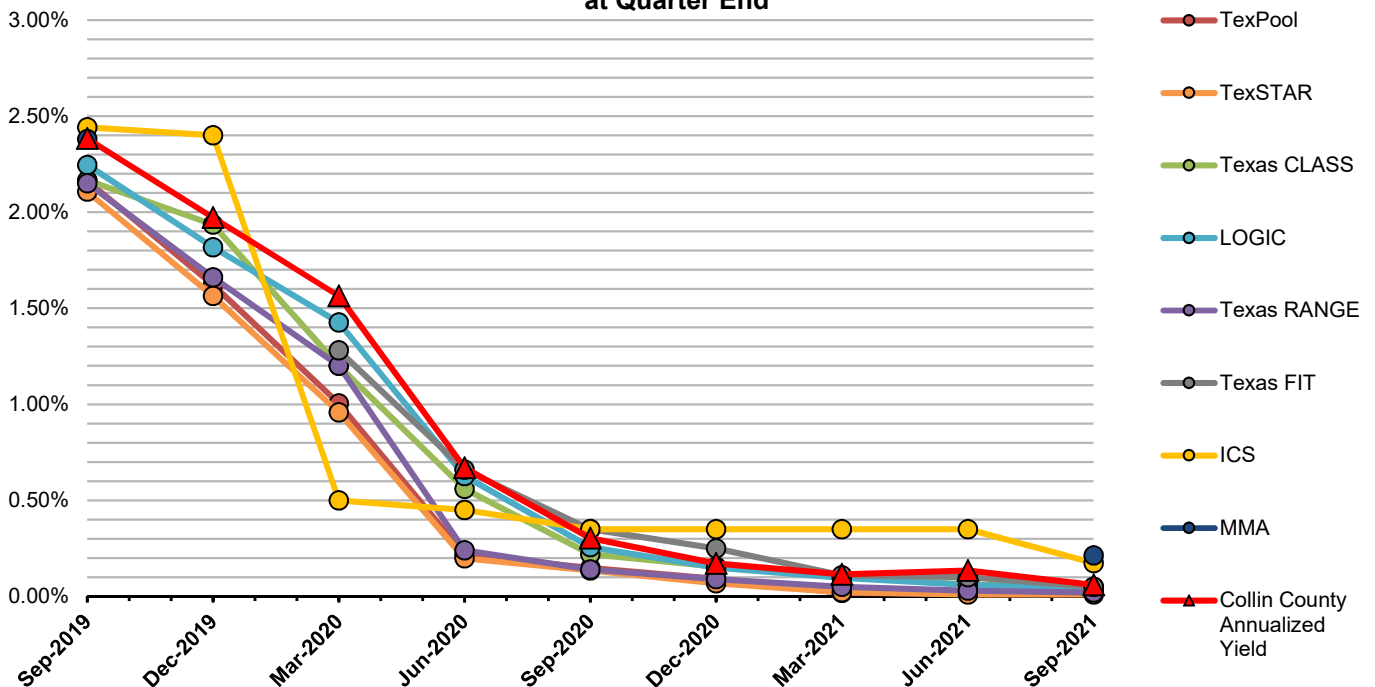
**Operating Investments by Type at Quarter End**

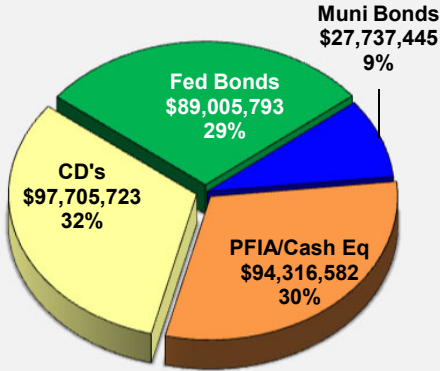

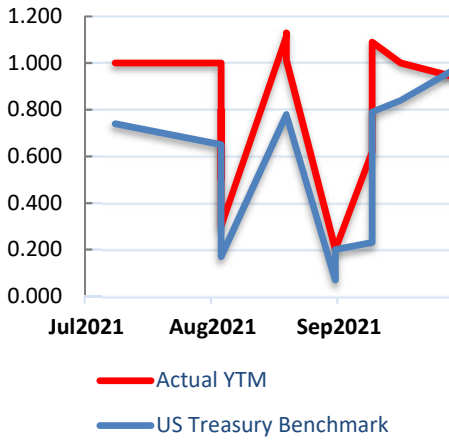

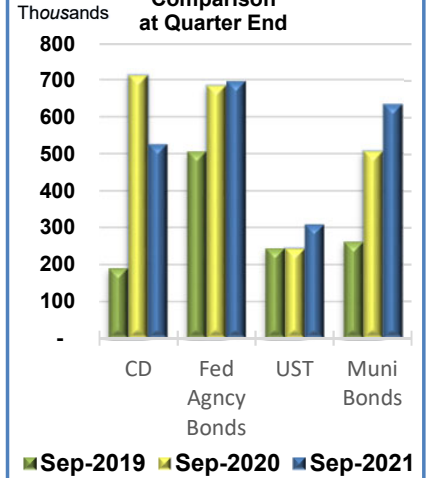
**Non-Operating Investments by Type at Quarter End**



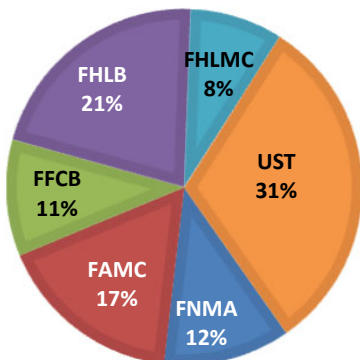
**Non-Operating Purchases YTM Versus US Treasury**



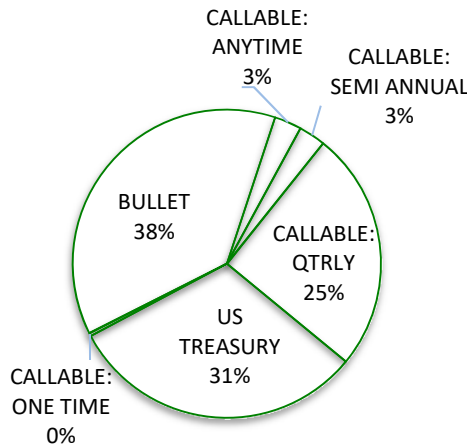
**Non-Operating YTD Interest Earnings Comparison at Quarter End**



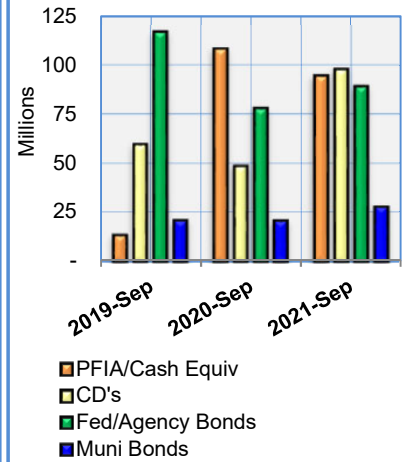
**Federal Agency Bonds Breakdown by Issuer**



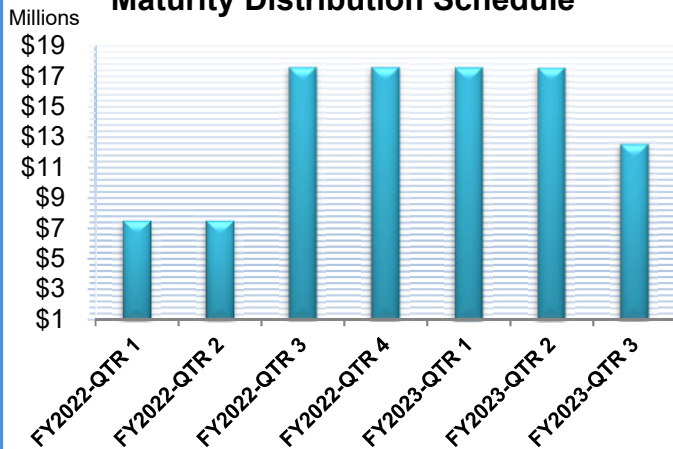
**Federal Agency Bonds Breakdown by Type**



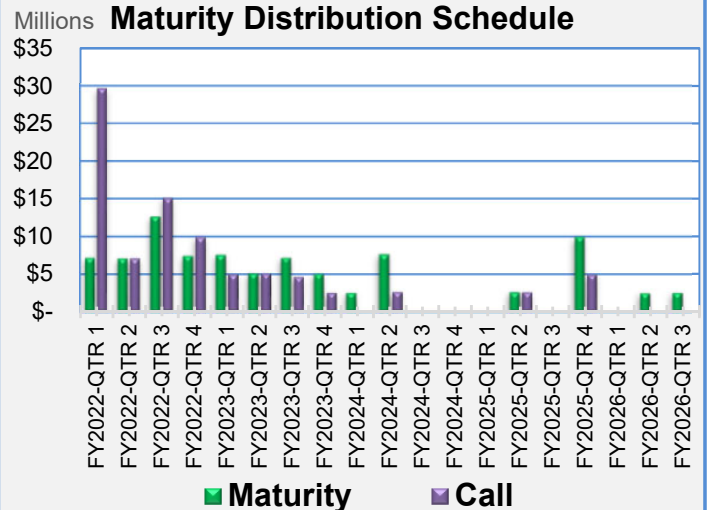
**Non-Operating Investments Three Year Comparison as of Quarter End**

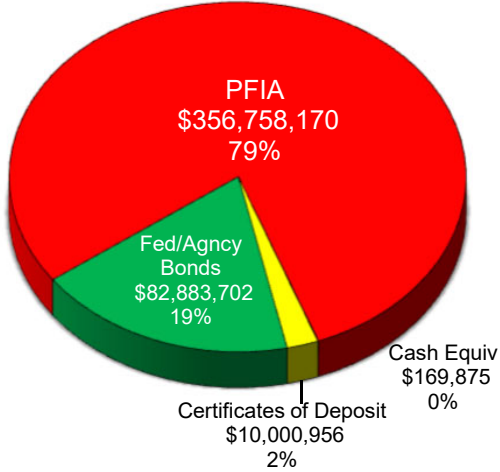

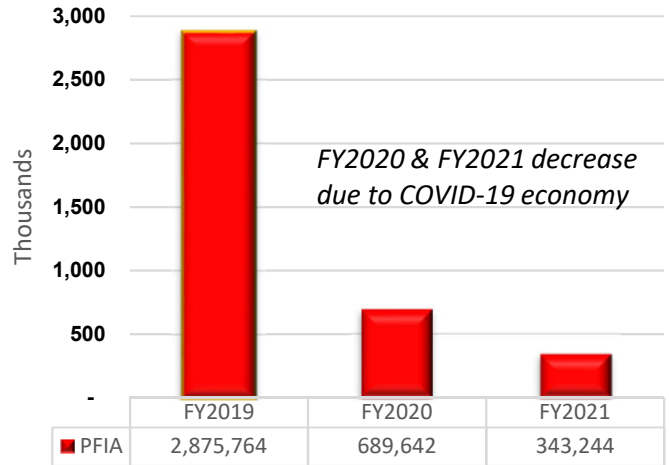

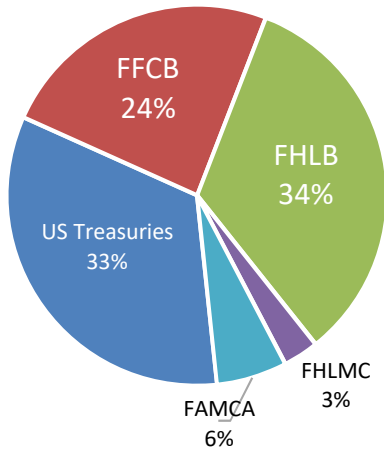
**Capital Projects Investments by Type**



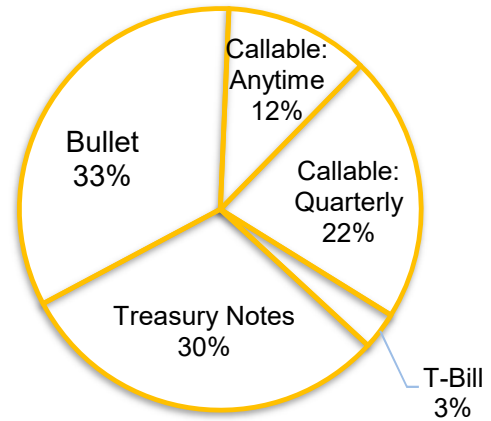
**Capital Projects YTD Interest Earnings**



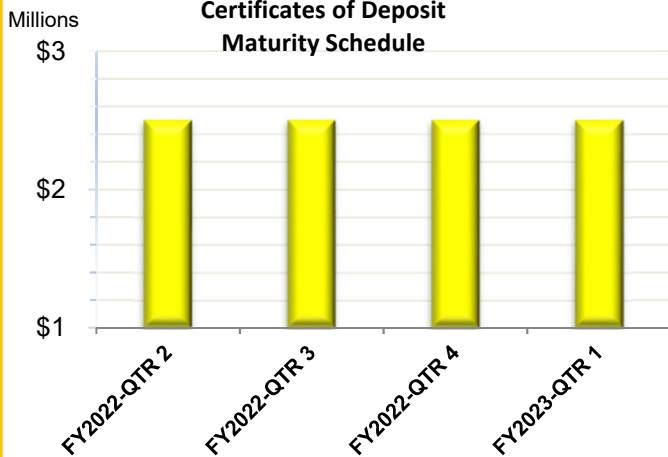
**Federal Agency Bonds Breakdown by Issuer**



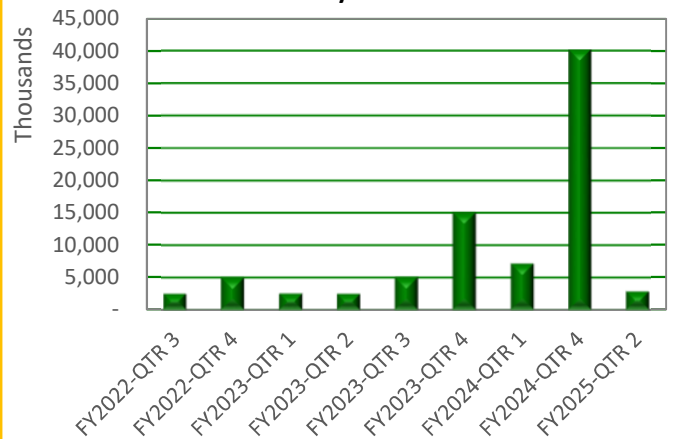
**Federal Agency Bonds Breakdown by Type**
