Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. and recessed the meeting at 1:38 p.m. The meeting reconvened at 1:38 p.m. and adjourned at 1:49 p.m.

## 4. Presentation/Recognition.

Judge Hill presented the Court and Tammy Mahan, Lifepath, with a check for \$1.5 million from the Attorney General's office to be used for opioid addiction abatement. Judge Hill said this check is from the State of Texas and the Attorney General to pursue opioid distributors and manufacturers who were profiting from opioid addiction and abuse. The Court will appropriate these funds, and Lifepath will help people in our community with their addictions.

#### **COMMISSIONERS COURT BUSINESS:**

#### Public Comments.

Scott Morrissey, McKinney, said he lives in Pecan Creek Farms and has issues with the roadway flooding. This is due to a neighbor building a retaining wall which has diverted water to the road and is flooding seven different neighbors. Mr. Morrissey said he discussed this issue with Commissioner Hale about a year ago and is still fighting for a solution. The neighbor was able to get permits from the County for additional fences so no water can flow on to their property, but this has caused more flooding issues. Previously, the subdivision was built so water flows through their property and into a retention pond. With spring coming and the potential for heavy rain, he would like the County to get the retention wall taken down since it is technically on county property. Mr. Morrissey sent Commissioner Hale photos of how bad the flooding can get on the road which is about one-foot deep.

Commissioner Hale said the Court, Public Works, and Engineering are working to find a solution. The Commissioner said he would meet with Mr. Morrissey after Court.

Robert Anzualda, McKinney, who also lives in Pecan Creek Farms, turned in a blue card but did not wish to speak.

Joshua Murray, Lavon, requested a future agenda item to discuss the turnover rate and the lack of personnel across all departments in the County. Mr. Murray said he thinks it would also be important to identify what the staffing needs will be in two years or more considering the jail expansion and the lack of a cleaning department. He is concerned about the maintenance of our roads if the County is having to pull maintenance and Public Works staff to clean the buildings. The Court also may need to buy more

technological items to scale out and add more employees. Currently, the County is on track to have fewer employees than it had in 2018, and the population is projected to grow 15%. So, when it comes to operational capabilities, the departments may reduce the level of service they provide. Mr. Murray also said he would like to see email lists for bids created by Purchasing and have inactive vendors removed.

Judge Hill asked Bill Bilyeu, County Administrator, if the County has a cleaning department. Mr. Bilyeu said the County has had one since January 1, 2022, and currently has 11 employees on the staff. Judge Hill also asked Mr. Bilyeu to meet with Mr. Murray after Court to elaborate on the technological items the County may need. Lastly, Judge Hill asked Mr. Bilyeu if removing vendors from email lists is a practical business practice. Mr. Bilyeu said there is an outsourced website the County uses to publish solicitations for bids. Vendors can sign up for the types of solicitations they would like to receive and even unrelated vendors can view the solicitation. Mr. Bilyeu said it is a good practice to have as many people as possible to view the solicitation, and removing vendors who willingly signed up to receive solicitations would be problematic.
