- 4. Click on the link. If the "apply" button is red you can begin the application using workspace (go to step 6). If it is grey, a workspace will need to be assigned to you
- 5. Call 800-518-4726 to have them look up who needs to provide you permissions from your County. They will give you a name to contact in your County.
- 6. Once you have access, click apply, and begin completing the form using workspace
  - a. Fill out file name with whatever you would like and click "create"
  - b. Click on blue link in bottom right to start application
  - c. Only fill out the boxes with red asterisks
- 7. Save form when filled out and then select "check for errors" at the bottom
- 8. Once no errors are indicated, close out, keep locked, and go back to main workspace page
