1. Revise Agreement No. 2021-353, paragraph two (2) to read: WHEREAS, the County desires to engage the services of the Architect to design and administrate a Program in a Construction Manager at Risk Design/Bid/Build Purchasing format, hereinafter referred to as the "Project". The Project shall include a 150,000 sf. Medical/Mental Health addition to the existing Adult Detention Facility, increased chiller capacity at the existing Central Plant, and a New Modular Central Plant located behind the existing Courthouse. The Project may also include demolition and remodel of an existing space to a new kitchen, expansion of the laundry/warehouse area, and remodel of the existing 24 bed infirmary to a 24 bed Skilled Nursing area; and \$0.00 2. Add additional topographic surveying for the area north of the proposed Phase 2 addition of the mental health wing and the south parking lots. Per BSW proposal dated 3/3/2022. \$9.000.00 3. Add cost estimating services for the Phase 2 addition of the mental health wing due to the determination that a Construction Manager at Risk would not be utilized for this project. Per BSW proposal dated 3/3/2022. \$55,500.00 4. Add architectural and engineering design and cost estimating services for the Phase 3 Skilled Nursing Renovation project.
