Thank you for the opportunity to provide a proposal to you for preconstruction estimating services for the Collin County Adult Detention Facility – Phase 2 in McKinney, TX.

Based on our understanding of your estimating needs, we propose to provide preconstruction estimating services to Brinkley Sargent Wiginton Architects for the lump sum amount of **Fifty-Five Thousand**, **Five Hundred Dollars** (\$55,500.00).

The anticipated scope and estimated duration of these services would be as follows:

- Schematic Design Estimate To be provided no later than Four (4) weeks after completion and delivery of schematic design drawings in March 2022;
- Design Development Estimate To be provided for preliminary review with BSW Architects approximately Five (5) weeks after completion and delivery of design development documents in July 2022, with subsequent delivery and presentation to the client if requested;

For accounting and payment purposes, a portion of the lump sum amount will be billed upon delivery of the schematic design estimate at \$21,000.00, with the balance due upon delivery of the design development estimate.

The above scope and durations do <u>not</u> include participation in monthly or weekly design meetings with BSW or the client. If this is desired, we will need some guidance as to frequency and duration. We have also excluded travel, meal & lodging expenses associated with such presentation and design meetings and recommend that these be handled as a direct reimbursement of actual cost.
