Applications for ballot by mail may also be faxed or emailed and must be received no later than the close of business on April 26, 2022. For an application for ballot by mail submitted by telephonic facsimile machine or electronic transmission to be effective, the hard copy of the application must also be submitted by mail and be received by the early voting clerk not later than the fourth business day after the transmission by telephonic facsimile machine or electronic transmission is received. (Texas Election Code 84.007, effective December 1, 2017). (Las solicitudes de boletas por correo también pueden enviarse por fax o correo electrónico y deben recibirse antes del cierre de operaciones del 26 de abril de 2022. Para que una solicitud de boletas por correo enviada por fax o transmisión electrónica sea efectiva, la copia impresa de la solicitud también debe enviarse por correo y ser recibida por el secretario de votación anticipada a más tardar el cuarto día hábil después de que se reciba la transmisión por fax o transmisión electrónica.
