POTENTIAL CHANGE ORDER DESCRIPTION: (The Contract Is Changed As Follows)

#### Existing 3" Gas Line

Provide for additional work required to excavate the existing 3" gas line on the east side of Pod 1 to see what it serves. We will then install a 3/4" verification tap and gauge to monitor the 3" HDPE pipe. After this, we will squeeze the line and isolate approximately a 6' section to monitor pressure. If the line is out of service, we will continue to squeeze and install 3" HDPE caps via electrofusion coupling to kill the out this 3" HDPE pipe. Lastly, we will backfill after the line has been capped.

Thank you for meeting onsite to discuss this ongoing project within the CCADF. SPS would be proud to assist with your HDPE squeeze, reducing, and abandonment work. I have separated the scope in (2) sections as we discussed earlier.

Abandonment

- Install 3/4" verification tap and gauge to monitor 3" HDPE.
- Squeeze and isolate approx. 6' section of 3" HDPE and monitor pressure. If line is out of service we will continue squeeze at (2) locations, cut out approx. 4' between squeeze points and install 3" HDPE caps via elocrofusion coupling to kill out the 3" HDPE.
  - Labor and Material for abandonment \$2,450.00

#### 6" to 3" Reduction to Future

- Fabricate and air test reducing spool for existing 6" section for future Data Plumbing 3" connection.
- Squeeze existing 6" HDPE and fuse new 6x3 reducing spool with 3" pup piece and end cap. Daum Plumbing to make future 3" HDPE connection.
  - Labor and Material for Reduction to Future \$3,645.00

SPS to provide all HDPE materials, tools, fusions, installation, and pressure testing (up to 1 hr air test w/gauge) for both abandonment and new install for future. Daum Plumbing to provide all excavation and backfill upon completion. No considerations included for site specific permits, clearances, etc.
