Public Comments.

Judy Dishong, Plano, said she is a member of CORE (Committee On Racial Equity), a group sponsored by Trinity Presbyterian Church in McKinney. The committee will focus on carrying out their faith by speaking up and stepping forward by advocating for racial equity in the community. The first goal is to listen to one another. CORE was established in 2020 with a two-prong strategy. The first being internal to the congregation and the second being external to the community. Monthly events are hosted to enhance the ability of congregants to engage in the difficult discussions around racism. The community strategy has initiated a ministerial alliance of pastors building relationships from various denominations. CORE is not a political group, but they will work against any action that attempts to set up or sustain systems that are based on looks or where a person lives. Ms. Dishong said it is not their intention to be confrontational but rather collaborative. The next steps for the committee are to attend the McKinney City Council meetings, the Collin County Commissioners Court meetings, the Collin County Board meetings, and the McKinney ISD (Independent School District) meetings. CORE recognizes that the City of McKinney is unique by nature. The committee also believes CORE is unique, and they look forward to working toward a more equitable community for all citizens. The goal is not to be divisive but to unify.

Joshua Murray, Lavon, said he would like to speak on agenda item AI-51977. This item is the filing of the April 4, 2022, meeting minutes which include public comments made by Mr. Murray. The comments were in regards to a contract that the city entered into for temporary workers. Mr. Murray said he had the

opportunity to attend a legal women voters briefing and Bruce Sherbet, Elections Administrator, was a speaker. Mr. Sherbet stated that, during the 2020 election, he needed approximately 40 temporary workers and was only able to obtain six. Mr. Murray said he brought up this agenda item because it is within the agenda and perhaps it gives the opportunity for the Court to actually speak on it. According to a letter dated March 8, 2022, a secondary temporary agency was selected, which pays \$13.60 per hour, as the primary agency because the cost was less. The primary agency had increased their cost to \$22.60 per hour. Perhaps the agency increased the cost because they needed 34 additional temporary workers. Mr. Murray said he understands that at the last budget the Court approved a last minute elections employee. As the Court reviews the budget, it is important to realize, if additional employees are approved and the Court does not provide the tools to recruit, then the department is really not getting anything at all. For instance, if the SO (Sheriff's Office) were to receive 100 new deputies to cover more area but no pay increase is approved, the SO would not be actually getting anything at all. Mr. Murray asked the Court to review the Elections Department and all other County departments. (Time: 2:26 p.m.)
