An order of the Commissioners Court approving the filing of the May 23, 2022 minutes.

On Monday, May 23, 2022, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Commissioner Fletcher led the Invocation.

Commissioner Hale led the Pledge of Allegiance.

Commissioner Williams led the Pledge of Allegiance to the Texas Flag.

Commissioner Williams called to order the meeting of the Collin County Commissioners Court at 1:30 p.m. and adjourned the meeting at 1:33 p.m. The meeting was reconvened at 1:34 p.m. and adjourned at 1:41 p.m.

Trustee Williams called to order the meeting of the Collin County Health Care Foundation at 1:33 p.m. and adjourned the meeting at 1:34 p.m.

COMMISSIONERS COURT BUSINESS:

Public Comments.

After agenda items were discussed, the Court heard Public Comments at 1:34 pm.

Joshua Murray, Lavon, thanked the Court for the opportunity to speak. He was hoping Judge Hill would be present but, given the holiday coming up, understands his absence. Mr. Murray said he is unsure what is going on, but for some reason the Court has begun asking Bill Bilyeu, County Administrator, questions after Mr. Murray's public comments. This can only be interpreted as attempts to make excuses and shift blame for things that are the Court's responsibility. Mr. Murray said he is concerned that the SO (Sheriff's Office) is understaffed and not equipped to keep pace with the demand brought on by the rapid growth in the County. He is also concerned the company that provides health care to the people in the jail is a liability to the County given their reputation.

Mr. Murray is also concerned the Elections Department does not have enough employees to provide safe and secure elections. He is very concerned about the County contracting with a temporary agency that charges near the same amount his 15-year-old son is hoping to make this summer. He is concerned the Tax Assessor's customer base has outpaced the staffing levels for too long, and his department is understaffed like many others in the County. He is concerned the County's Public Information Officer is unable to execute the most basic request for information by stating the system's search functions for reviewing information is too burdensome for referencing limitations. As a result, he is refusing to fulfill requests for information. Similar requests have been fulfilled by the City of Lavon. Mr. Murray said he doesn't speak at meetings to make Judge Hill feel bad or hurt his feelings. He is speaking on concerns that have been issues for too long and to ask the Court to do something about them. The Court may not be discussing the budget, but it is happening behind the scenes. It is imperative that the County has the necessary infrastructure which includes departments being properly staffed. For the record, an information request was made on April 30, 2022, and on multiple occasions the County has required Mr. Murray to narrow his request which he has done. The County has refused the request and said he should file a complaint with the Attorney General's Office.

Andie Gonzalez, Frisco, said she wanted to speak about things happening in our school districts. Ms. Gonzalez said she knows the school districts are at the state level, but there are certain school boards that are using the police force unfairly against a certain group of people. During school board meetings, there are rules such as no disruptions or clapping. However, the parents are not being treated equally. One group of parents are allowed to do those things, and other groups of parents are being physically and forcefully removed when doing the same thing. Ms. Gonzalez said she was one of the parents that was removed. Ms. Gonzalez wanted to know if the Court knew about this issue, and if they are willing to put together an agenda item to talk about how the police force needs to have parameters.

Ms. Gonzalez asked if the Court could answer questions. Commissioner Williams said they are not able to answer questions. Ms. Gonzalez said the parents were removed because they are against sexually explicit materials and resources distributed in the school libraries. These books have no educational value. This is an issue in McKinney, Frisco, Allen, and Plano. There were over 850 books in all of those school districts. The school board has the right to remove these books when they are not appropriate. The material is extremely pornographic in nature, and it shouldn't be in the schools at all. There are federal and state laws that prohibit the distribution of explicit materials to minors, and these are minors. The parents have asked for these materials to be removed but were told there is a process they have to follow. Ms. Gonzalez said she homeschools her kids and, if she were to have these materials at her home, she could be arrested. (Time: 1:41 p.m.)
