Public Comments.

After General Discussion, the Court took Public Comments.

Joshua Murray, Lavon, said his family lives in Lavon, and their school district is Community ISD (Independent School District) which has a population of 4,000 students. Mr. Murray said the school district has grown at an accelerated rate, and Lavon is projected to add over 7,500 homes over the next five years. Community ISD proposed a \$650 million bond package with a warning stating all schools will surpass capacity within two years without the bond. Mr. Murray said people from Lavon, Josephine, Nevada, Copeville, and Farmersville voted and approved this bond. This is the second bond within the past 2 years proposed by Community ISD for a total of \$760 million. The growth in this area is so significant that the new elementary school, which opened in December 2021, is already at capacity. This year, a new MUD (Municipal Utility District) will bring 4,000 new rooftops to the district in addition to the Magnolia Point MUD which brought 1,600 homes to the district. These new homes require essential services which have raised prices and decreased the quality of education. Mr. Murray said the cost of living

in rural areas has reached levels that are unsustainable as developers use tax incentives to force

astronomical growth. (Time: 1:37 p.m.)
