1) Call to Order

The meeting was called to order at 7:00 p.m.

2) Moment of Silence - Observed

3) Pledge of Allegiance - Recited

4) Roll Call

Attending was Cynthia Sandlin, Cindy Cash, Bob Petitt, Pat Kelly and Peter Christian.

5) Discuss, consider, and act to approve the consent items: Meeting minutes of June 14, 2022, and Financial Statements and permits for June 2022.

Peter Christian made a motion to approve the consent items; second by Pat Kelly. Motion passed unanimously.

The updated application was reviewed and approved. Pat Kelly made a motion to move forward with appointing someone to the open seat; second by Peter Christian. Motion passed unanimously.

c. Discuss, consider and act to approve franchise agreement for Change Recycling.

d. Discuss, consider, and act on name and/or change for Myrick Lane.

Bob Petitt explained the reasoning for the name change on the Lowry Crossing portion of Myrick Lane to "Old Myrick Lane." Pat Kelly made a motion to approve the name change; second by Peter Christian. Motion passed 3-1.

e. Discuss, consider, and act to approve Resolution 111 accepting the 2022 update of the Collin County Hazard Mitigation Plan.

Pat Kelly made a motion to approve Resolution 111; second by Cynthia Sandlin. Motion passed unanimously.

f. Discuss, consider, and act on appointments to the Park Advisory Board.

A slate of self-identified volunteers was presented to council. One additional candidate was brought forward in the meeting. Pat Kelly made a motion to approve all seven candidates; second by Cynthia Sandlin. Motion passed unanimously.

Pat Kelly made a motion to approve Ordinance 351; second by Peter Christian. Motion passed unanimously.
- h. Discuss, consider and act to order the November 8, 2022 Election by Election Order.**
Pat Kelly made a motion to approve the November 8, 2022 Election Order; second by Cynthia Sandlin. Motion passed unanimously.
- i. Discuss, consider, and act to approve the FY 2023 budget for the city.**
Pat Kelly made a motion to approve the FY2023 budget; second by Cindy Cash. Motion passed unanimously.
- j. Discuss, consider, and act to approve the FY 2023 budget for the EDC.**
Pat Kelly made a motion to approve the EDC FY2023 budget; second by Cindy Cash. Motion passed unanimously.
- k. Update and action to approve funds for equipment purchase from Collin County.**
The County has equipment it will be retiring from service that we can purchase at a reduced rate. There is a tractor, bat wing mower, pick up truck, backpack blower and chainsaw for \$30,212. Cindy Cash made the motion to approve \$30,212 for equipment purchase; second by Pat Kelly. Motion passed unanimously.
- l. Discuss, consider, and act to on Collin County call for projects and engineer retention.**
Bob Petitt explained the Call for Projects and suggested that we consider entering the Myrick Lane connection to FM546 as a joint project with Princeton as this gets traffic out of Lowry Crossing sooner. Simpson Road would also qualify, but we don't need it yet.
Pat Kelly made a motion to move forward with Myrick; second by Cindy Cash. Motion passed unanimously.
