Honorable Judge Chris Hill-

I am requesting paid-overtime be extended for juvenile detention operations. The current approval is set to expire as of 08/14/22. I am requesting paid-overtime be extended until September 25<sup>th</sup> in order for us to meet our statutory staffing minimums for the facility. Funding to cover this request will come from the department's established funding (open-positions) per the usual process. While we are making significant progress in our recruiting efforts, we are not out of the woods as it relates to mandatory minimums for juvenile detention operations. As you know, we operate with an extremely thin workforce when fully staffed to begin with.

Currently, we have nine (9) openings which is huge improvement from our recent count of 14 openings. Eight (8) of our new recruits are working toward certification (currently not certified) which statutorily limits their assigned duties. We also have multiple officers on ADA (3), and others on FMLA and light-duty limitations. In concert with getting our new officers certified and fully functional, we will need our currently certified staff to bridge the gap in covering extra shifts to meet our mandatory staffing ratios and operational requirements. We have a large training scheduled for September with ten (10) officers attending, and if we are fortunate enough to get some of our recent interviews through the screening process successfully, we look to be in much better shape going into the next fiscal year and holiday season. That is if COVID does not decide to wreak havoc on us like in the past. We just had three (3) officers infected but they were able to isolate and have been cleared to return. I know Tarrant County was just hit hard with COVID so we are being diligent in our mitigation practices to keep everyone safe.

Your consideration is very much appreciated in this important request. Your support in this matter has made all the difference for our staff, the county, and our youth during these past few weeks. I am including some additional articles regarding the current crisis facing the juvenile justice system for informational purposes also. If you have any questions, please do not hesitate to let me know. Thank you again for your time and consideration.

Good afternoon Judge Hill—
We are still in crisis as it relates to meeting our statutory requirements for juvenile detention facility staffing. Our population has increased to more than 100 youth and we continue to lose staff regularly who are accepting jobs in other industries, e.g. flight attendant, school teacher most recently. I am respectfully requesting paid-overtime for our facility operations be extended from 05/23/22 through 08/14/22. I appreciate your consideration and support in this important request and will be happy to answer any questions you may have.
I am hopeful the pace of juvenile arrests will temper some with school ending soon but there are no guarantees. While I am hopeful, I am not overly optimistic as violent juvenile crime is occurring at alarming rates at this time.
