All requests for price redetermination shall be in written form, shall be submitted a minimum of thirty (90) days prior to anniversary date, and shall include documents supporting price redetermination such as Manufacturer's direct cost, postage rates, Railroad Commission rates, federal/state minimum wage law, federal/state unemployment taxes, FICA, insurance coverage rates, etc. The bidder's past experience of honoring contracts at the bid price will be an important consideration in the evaluation of the lowest and best bid. Collin County reserves the right to accept or reject any/all of the price redetermination as it deems to be in the best interest of the County. To:
