- Apply a sealer and damp proof asphalt emulsion with plastic to the affected chilled water locations to act as a corrosion barrier and insulator. Labor and Material: \$1,204.00
- Rent shoring and trench boxes to perform the bullet point above. Rental Equipment: \$1,980.00
- Procure and backfill 125cu yd of 3/8" chat to the chilled water pipe trench. Labor and Material: \$9,390.00
- Procure and backfill 40 cu yd of 1-1/2" road base to the top layer of trench. Labor and Material: \$4,310.00

General Conditions – Clarifications

- **a.** Work Hours: There are no restrictions on work times. The work will be performed on a standard 5 day/40 hour week
- b. No temporary MEP equipment is included.
- c. Brandt will clean up debris and remove it from the site
- d. Permits: Not Included
- e. This proposal is valid for 30 days. After 30 days, we would like the opportunity to refresh our pricing if necessary.

Exclusions

- 1. Heat tracing of any kind, heat trace wiring, or heat trace circuits.
- 2. Sales Tax, Payment, performance or bid bonds. Bond pricing is available on request.
- 3. Modification of other existing systems or conditions in order to bring up to current code, except as specifically stated and included.
- 4. Any painting.
