Attachment C Pre-Bid Questions/Answers & Clarifications

- Q. For line item 24, five year sprinkler system inspections, which locations are included?
 - A. Only the locations referenced in the specs as requiring these inspections during the contract period: Central Plant, Animal Shelter, Medical Examiner, Administration Building. (Post-meeting Clarification: Refer to Section 4.19.11)
- Q. For the buildings requiring five-year inspections during the contract period, are these all single riser buildings?
 - A. Yes these are all small buildings. (Post-meeting Clarification: Refer to Section 4.19.11)
- There was a clarification regarding vendor response times by Facilities: The County would require
 a 2-hour response time during a life safety emergency, which would include any time we have to
 shut down the system. The County would require a 2-day response time if there is not a life safety
 emergency, such as if the system was still functional but showed trouble codes.
- Facilities stated that it was preferred that no subcontractors be utilized by the awarded contractor. (Post-meeting Clarification: Bidders may utilize subcontractors under a contract resulting from this solicitation. Refer to Section 4.15 regarding subcontractors.)
- Q. For fire hydrants and other underground fire related utilities on the property, who would handle these in an emergency?
 - A. Collin County is responsible for these on County property. The County is responsible for any repairs but these would be fixed by another vendor (currently plumbing contractor).
- Q. What version of NFPA are we currently using?
 - A. This is determined by City of McKinney and should currently be 2016.
- Q. Is the use of performance bonds new?
- A. No this has always been there, but this only applies to work considered as public works projects and won't apply to testing and maintenance. (Correction: bonds were not part of the previous contract)
 - Q. What are the specs at 4.9 stating?
 - A. This is a standard clause that may not apply. This is not referring to the testing of a fire sprinkler or alarm.
 - Q. Is EST the only system used by Collin County?
 - A. The County uses EST 3 at all locations. The Courthouse uses EST 3 with a Kidde pre-action panel.
 - Q. If the contract is awarded by section, how would the Courthouse pre-action be split?
 - A. The Kidde pre-action system at the Courthouse would need to fall under the sprinkler test. (Post-meeting Clarification: The Kidde system at the Courthouse should be broken into two different inspections. The Fire Alarm side should inspect the panel and the Sprinkler side should inspect the tanks and pre-action systems.)

Attachment C Pre-Bid Questions/Answers & Clarifications

- Q. Are special tags required for dampers when inspected?
 - A. No special tags required.
- Q. What format is expected for inspection reports?
 - A. Reports should follow NFPA guidelines.
- Q. Is the Courthouse the only location with pre-action?
 - A. No both the jail and courthouse have pre-action.
- Q. What kinds of concerns do have with previous contractor?
 - A. Just response times.
- Q. How have you been working with supply chain issues?
 - A. The County knows sometimes we just have to wait for things to come in, but documentation and regular updates are needed.
- Info provided by Facilities: The sprinkler heads in inmate areas at the jail will be pulled due to new guidelines. (Post-meeting Clarification: This plan has not been approved or implemented by the County at this time and should not be considered by bidders in their response to this solicitation.)
- Q. Do you do pump checks in-house?
 - A. Yes this is part of the County's monthly checklist.
- Q. Do you have fire curtains?
 - A. No.
- Q. Do you have audio shut off for fire alarms in the courtrooms?
 - A. No the alarms go off in the courtrooms same as everywhere else. Throughout building audio can be silenced but strobes will continue to go off until alarm is cleared.
- Q. At the jail do they check the fans for smoke detection?
 - A. They only check one pod.
- Q. How many fire system backflow devices to be inspected and are there backflow devices in vaults?
 - A. There are approximately 12 total fire system backflow devices; 4-5 are in vaults.
