Additionally, excavate on the east side of the west storm manhole box to determine what size the existing RCP pipe is from west manhole to the east manhole near the existing headwall per request of the Architect. This additional work will provide the Architect and Civil Engineer with the information they need to finalize the forthcoming PR per RFI #44 & #51. (1.5 DAYS OF WORK PLUS RC BONDS & FEE TOTAL ADD 6,267.73)
