Judge Hill led the Invocation.

Commissioner Webb led the Pledge of Allegiance. Commissioner Williams led the Pledge of Allegiance to the Texas Flag.

Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. The meeting was adjourned at 1:47 p.m.

President Hill called to order the meeting of the <u>Collin County Health Care Foundation</u> at 1:47 p.m. and adjourned the meeting at 1:47 p.m.

# COMMISSIONERS COURT BUSINESS:

# Public Comments

Judge Hill said, at the end of the meeting on Monday, September 19, 2022, there was confusion. Some public speakers said they didn't have the opportunity to speak. The Judge said everyone who turned in a blue card had the opportunity to speak during the public comments session. However, some people thought they would be able to speak twice during the meeting - once for each subject listed on their blue card. The Judge said the public's confusion was his fault, and he apologized. Public comments related to agenda items are heard at the beginning of the meeting, and public comments not related to the agenda are heard at the opportunity to speak once regardless of the number of topics listed on their blue cards. If any of the subjects are related to an agenda item, the Court would like to hear the comments before taking a vote on the agenda. Judge Hill thanked the public for their patience and understanding. None of today's blue cards turned in were related to the agenda so Judge Hill moved on to the consent agenda. (Time: 1:34 p.m.)

Public Comments were heard after the consent agenda vote.

Judy Dishong, Plano, said she felt disrespected during discussions that occurred after the meeting on Monday, September 19, 2022. Judge Hill followed her and said Ms. Dishong hasn't voted for a republican in a long time. Ms. Dishong said her voting record has nothing to do with her status as a citizen of Collin County and as a taxpayer. Ms. Dishong said she does a lot of research before voting for a candidate and does not listen to friends or pay attention to a candidate's flyer. The Commissioners need to recognize they are not dictators or her boss. The citizens and taxpayers are the Commissioners' employers. Ms. Dishong said she only cares about the Court doing the best job for Collin County. One issue she has been speaking about is the lack of information citizens get from the Court. Many of her friends don't know what the Commissioners Court is or that it even exists. Ms. Dishong requested more information to be given to citizens. This would include what the Court does and what is happening in the county. Information could also include positive things such as the new center for citizens with mental illnesses being built for the SO (Sheriff's Office).

Debbie Lindstrom, McKinney, thanked Judge Hill for his apology and clarification. Over the past few months, likeminded citizens have been attending the Commissioners Court meetings to speak about election integrity. Many did not know one another until they started attending the meetings. Together they have voiced their distress with the elections system, and they are not alone. On August 8, 2022, Rasmussen reported 62% of voters are concerned about the possibility of cheating in the upcoming election. Majorities of every political category – 67% of Republicans, 53% of Democrats and 58% of unaffiliated voters – believe election integrity will be a very important issue in this year's congressional elections. Many citizens believe there have been inaccuracies in past Collin County elections. In recent weeks, some of these issues were brought to the Court's attention because they know the Court wants accurate elections too. The concerned citizens also recognize the Court is busy running the County, and they can't monitor everything. Therefore, many citizens will be engaged and working during the elections. They will be monitoring and looking for discrepancies. The people of Collin County want to do what they can to have free, fair, and accurate elections in November. Ms. Lindstrom asked the Court to work with Collin County citizens to fix or answer any inaccuracies that may be discovered.

Joshua Murray, Lavon, congratulated Judge Hill for apologizing and admitting he was wrong. He also said he was given a no bill by a special grand jury regarding the disruption of a meeting after Judge Hill found him in contempt of court. During a public comment on the May 24, 2021, Mr. Murray asked the Court to discuss the safety and suitability of the jail. Upon completion of his remarks, Judge Hill ordered Mr. Murray to leave the Court by saying, "You are dismissed." Never before or since has the Judge dismissed any speakers. Mr. Murray responded by telling Judge Hill, "Do not dismiss me." Judge Hill responded in a tone reminiscent of a schoolyard bully, "No, you are dismissed". Judge Hill then ordered Mr. Murray to have a seat but was not able to because the person in the first row would not stand up to let him by. At this point, Mr. Murray turned back towards the Court, and Judge Hill ordered him to be removed from the courtroom. As the Constable approached, Mr. Murray told him he was waiting on the motion made by Judge Hill. The Judge then made a motion to find Mr. Murray in contempt for not leaving. The motion received a second and ultimately passed as Mr. Murray was escorted from the courtroom. The amount of time following the end of Mr. Murray's comment and the time he was found in contempt of court was 35 seconds. Each Commissioner acted recklessly in supporting this tyrannical motion. Cutting off the microphone, mocking speakers, not allowing those who pray in silence to finish their comments, or allowing some people to make comments with hats on while not allowing others to do the same are all examples of the Court violating the constitution. The 14<sup>th</sup> Amendment gives the Court the right to protect people's liberty. It is not up to the Court to decide who wears a hat and who doesn't. The Court is there to set rules and enforce them equally to all.

Chuck Reynolds, Celina, said he wanted to speak on election integrity and said verification and accuracy of votes is needed. Mr. Reynolds said he recognizes the Court has a challenging role and appreciates what they do. These are also challenging times. The citizens have figured out the election machines are not securable, and further evidence has come out proving so. Election machines have been in place for two decades or more and were inherited. This is not the Court's fault, but it is now their responsibility. Citizens are telling the Court the machines are not secure and have provided evidence. More than 60% of Americans don't trust elections. Mr. Reynolds asked the Court to help concerned citizens and for verification of votes for the upcoming election. (Time 1:46 p.m.)
