**SECOND AMENDMENT
TO
SOFTWARE LICENSE AGREEMENT**

This Second Amendment to Software License Agreement (this “Amendment”) is entered into as of 31st day of October 2022 (the “Effective Date”) by and between **GreyHeller, LLC dba Apsian**, a Delaware corporation, having its office at 8111 Lyndon B Johnson Fwy #1475 Dallas, TX 75251 (“**Apsian**”) and **Collin County**, Texas a political subdivision of State of Texas (“**Customer**”). Terms not otherwise defined herein will have the meanings ascribed to them in the License Agreement (as defined below).


RECITALS


- A. Apsian and Customer are parties to a Software License Agreement dated 17th December 2018. (the “License Agreement”).
- B. Apsian and Customer now wish to amend the License Agreement to increase the price for the next contract period of 12/17/2022 to-and-including 12/16/2023.
 - 1. Effective as of the Effective Date, the License Agreement is amended as follows:
 - a) The parties hereby agree to a price increase for the term of 12/17/2022 to-and-including 12/16/2023 for a price of \$89,462.00 per §8(a). The body of the License Agreement and Exhibit A thereto will be deemed so amended accordingly.
 - 2. No Other Provisions Affected. Except as provided herein, all terms and conditions of the License Agreement remain in full force and effect and may only be modified in writing signed by both parties.
 - 3. Counterparts. This Amendment may be executed in counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.
