AMENDMENT

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc. with offices at One Tyler Drive, Yarmouth, Maine 04096 ("Tyler") and Collin County, Texas, with offices at 2300 Bloomdale Road, McKinney, Texas 75071 ("Client").

WHEREAS, Tyler and Client are parties to an agreement dated April 26, 2016 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the terms of the Agreement as provided herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and Client agree as follows:

- 1. The items set forth in the Investment Summary attached hereto as Exhibit 1 are hereby added to the Agreement. Fees for such items shall be invoiced as follows:
 - a. <u>Hardware Fees</u>. Fees for Hardware are invoiced on delivery of the respective Hardware.
 - b. <u>Hardware Maintenance</u>. The first year maintenance fees for the Hardware are invoiced on delivery of the respective Hardware.
 - c. <u>Transaction Fees</u>. Unless paid directly by an end user at the time of transaction, per transaction (order, call, message, etc.) fees are invoiced on a quarterly basis. Fees are indicated in Exhibit 1 and may be increased by Tyler upon notice of no less than thirty (30) days.
- 2. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
- 3. Except as expressly indicated in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
