A few weeks ago there was an agenda item to allow Judge Raleeh's retiring court administrator the opportunity for additional time to train her replacement. The Court approved the Judge's office to have

two in the court administrator's position for a one month period. Today, Judge Raleeh requested a 30 day extension. Since the Judge promoted from within his department, Commissioner Webb feels it may not be necessary to do this extension. Commissioner Webb invited Judge Raleeh to respond.

Judge Raleeh, Justice of the Peace, Precinct 1, said, even though he promoted from within his department, there is a great deal this person does not know such as finances, audits, state reports, and computer systems. Therefore, the Judge feels 30 days is insufficient for them to be adequately trained. Furthermore, the Judge stated, when the Court originally approved the one month of training, it was under the assumption the court administrator was retiring on December 31. However, she is actually retiring January 31. The Judge has extra funds which were carried over when a legal clerk position was not replaced. The Judge would like to use these funds to pay for the new court administrator's training. He asked the Court to extend the training for an additional 30 days, and he will work the rest of the details out with HR (Human Resources). Commissioner Webb was concerned with the court administrator deciding to change their retirement date. Judge Raleeh said she was always going to retire at the end of January. There was a typo by HR when submitting this item for approval by the Court. When Judge Raleeh noticed the mistake, HR suggested bringing it back before the Court.

Cynthia Jacobson, Human Resources, confirmed there was a communication error regarding the retirement date. Commissioner Hale said he was fine with leaving the item as is. The funds available from the open position can be used to pay for this additional time for training. No motion was taken on this item.

Public Comments not related to an item on the Agenda.

Joshua Murray, Lavon, came to speak on several items of concern and to announce he will be back next year. Mr. Murray was greatly concerned regarding the agenda item where an elected official didn't allow auditors to do their job. He thanked Commissioner Webb for highlighting this issue and said this item should never have been on the consent agenda. It should have been listed as a topic for discussion from the beginning. Mr. Murray noticed for the second week in a row a dead cricket on the floor in the back corner of the Court. He said the janitorial service needs to be tackled at the same time properly budgeting overtime for the Sheriff's office. Regarding the microphone button installed this year behind Judge Hill's desk, Mr. Murray said someone needs to manage it when Judge Hill is not present to ensure people watching online can hear what is said. For the Deputy's Association, Mr. Murray said it's imperative the County recognize the importance of having a non-partisan body or association especially given recent allegations of sexual harassment. He said it's beneficial for employees to have such non-partisan associations where employees feel they can raise concerns and issues. Lastly, Mr. Murray stated his concern regarding the need to update the building code due to upcoming capital improvement projects such as building schools in rural areas. Until the code is updated, schools have the option to build without a tornado shelter.

Sheena King, McKinney, shared with the Court the November publication from the FCC (Federal Communications Commission) of a broadband map. She wants to make sure everyone is aware of this map due to the reliance on broadband for our daily lives. Ms. King said it is important the map accurately shows where the County has broadband as well as where there are gaps. She is bringing this forward to provide an opportunity for the public to communicate any inaccuracies or gaps. The window to provide comments to the FCC started November 18, 2022 and will end January 13, 2023. Anyone can go to the FCC website to help improve the map. People can provide updates regarding information on counties, schools, or specific areas. Communication providers have already given their input, and Ms. King wants to give the community their opportunity to provide input and let the FCC know where they are under served. The map can be found at www.Broadbandmap.fcc.gov. People can choose to submit a location challenge or service availability challenge.

There being no further business of the Court, Commissioner Webb adjourned the meeting at 1:50 pm.
