RE: Recommendations for FY'22 Health Care Service Agreements

On January 20, 2022, the Collin County Health Care Advisory Board met and reviewed (6) applications from non-profits requesting funding to provide health care services. Funding of **\$140,000 for non-profits** was approved during the FY 2022 budget process. As directed by the Board of Trustees, the Health Care Advisory Board made their funding recommendations, based on the following criteria:

Types of services limited for funding:

- Sick medical visits (including specialist visit, provided by a licensed health care provider);
- Laboratory and x-ray services;
- Prescription drugs (generic when available); and

Recipients of services must be Collin County, Texas residents who are:

- U.S. citizens or Legal Resident Aliens with more than 40 working quarters of U.S. employment; and
- Uninsured and have household incomes at or below 100% of the Federal Poverty Level.

After lengthy discussion and consideration, the Health Care Advisory Board **unanimously voted to recommend \$120,000.00**, in funding for the following non-profit agencies based on previous performance and utilization of past funds awarded. **Awarded amounts for each agency were calculated on percentage of award utilized within the past two grant year cycles, as well as reviewing the requested dollar amounts and its percentage of the agency's total annual budget.*

Allen Community Outreach - \$2,000 (of \$3,000 requested) for sick medical visits, prescription assistance, laboratory and x-ray services.

Community Health Clinic - \$50,000 (of \$50,000 requested) for sick medical visits, laboratory and x-ray services.

Community Health Service Agency, Inc. D/B/A Carevide - \$12,500 (of \$50,000 requested) for sick medical visits, prescription and laboratory assistance.

Health Services of North Texas - \$12,500 (of \$50,000 requested) for sick medical visits, laboratory and immunization services.

Hope Clinic of McKinney - \$40,000 (of \$50,000 requested) for sick medical visits, prescription assistance and laboratory services.

The Samaritan Inn - \$3,000 (of \$10,350 requested) for sick medical visits and prescription assistance.

If approved by the Trustees, service agreements will be sent out to the non-profits for signature and the service agreements will be placed on court for final approval. The Advisory Board is also recommending that the remaining **unallocated amount of \$20,000 be held in contingency for non-profits** if critical funding needs are identified during the fiscal year.
