The raw materials in these products continue to be under extreme pricing pressure. However, we believe at some point in time this trend will reverse itself. The question on all of our minds is when...?

We track general raw material cost trends through the U.S. Bureau of Labor Statistics and their Producer Price Indices. We have attached a current PPI Indices report for your review.

We will continue to closely monitor inflation and cost trends and keep you informed of what we learn.

The cost of phosphates has increased dramatically over the last 2 years (50% increase in 2021 and another 39% YTD in 2022). Why are phosphorus prices going up? Soaring prices are driven by a confluence of factors, including surging input costs, supply disruptions caused by sanctions on Belarus and Russia, and export restrictions in China.

In addition, there continues to be price pressure on caustic soda. We track these raw material cost trends through the U.S. Bureau of Labor Statistics and their Producer Price Indices. We have attached a current PPI Indices report for your review.

As a result of these cost increases, we will be raising prices on two ware wash detergents on Jan 1st, 2023. #61494 Solid Performance will be increase by 8.9% and #61354 Applause will be increased by 7.2%.

The good news is that Sunburst has several ware wash detergents that are formulated without phosphate (Performance Plus as an example). We are not raising prices on these products. These might be good options for you to consider.
