It is our pleasure to inform you that your agency, as an active affiliate of the North Texas Internet Crimes Against Children (NTICAC) Task Force, has been selected as a subgrantee for the FY22-23 Federal ICAC grant through the

Department of Justice. Your agency's selection by the North Texas Task Force Commander is based on your commitment of personnel and resources to combating Internet-based child sex crimes and the exploitation of children in the North Texas region. Your agency's ICAC personnel and supervisors have shown relentless follow-up and dedication to promptly investigating all Cybertips assigned to them. They have consistently provided feedback, activity, and stats required for reporting by DOJ to the Dallas ICAC promptly and have been active affiliates by attending meetings and training events.
