A resolution of the Collin County Commissioners Court supporting the expansion and realignment of FM 428 to the East to intersect with State Highway 289 using County Road 55/W. Glendenning Parkway.

Whereas, the Collin County (County) owns and operates a system of roadways for public use and benefits including County Road (CR) 1214, and

Whereas, the County of Collin recognizes the City of Celina (Celina) owns and operates a system of roadways for public use and benefits including County Road (CR) 55, Dallas Parkway Frontage Road and W. Glendenning Parkway, and

Whereas, the County of Collin recognizes the Texas Department of Transportation (TxDOT) owns and operates a system of highways for public use and benefits including Farmers Market (FM) 428, Farmers Market (FM) 455, United State (US) 380 and State Highway 289 (Preston Road), and

Whereas, the County of Collin recognizes the North Texas Tollway Authority (NTTA) owns and operates a system of highways for public use and benefits including Dallas North Tollway (DNT), and

Whereas, the County of Collin recognizes TxDOT will be improving and expanding FM 428 from approximately 1300 feet west of the Dallas Parkway Frontage Road south bound lanes to Preston Road (SH 289), and

Whereas, the County of Collin recognizes the North Texas Tollway Authority (NTTA) will be extending DNT from US 380 to FM 428, and

Whereas, the County of Collin recognizes the realignment of FM 428 to tie into Preston Road (SH 289) in lieu of FM 455 will help to relieve heavy vehicle traffic through City of Celina Downtown thus promoting public safety and travel efficiency, and

Whereas, the County of Collin recognizes the realignment of FM 428 process involve bringing portion of CR 1214, CR 55, and W. Glendenning Parkway from approximately 1600 feet east of CR 55 to Preston Road (SH 289) in to TxDOT system, and

Whereas, the County of Collin recognizes the realignment of FM 428 process involves removing the northern section of FM 428 from CR 1214 to FM 455 from the TxDOT system, and

Whereas, the County of Collin recognizes TxDOT to assume ownership and operation of the portion of CR 1214, CR 55, and W. Glendenning Parkway (from approximately 1600feet east of CR 55 to Preston Road (SH 289)) that will be brought onto the TxDOT system upon completion of the process, and

Whereas, the County of Collin recognizes City of Celina to assume ownership and operation of the northern section of FM 428 from CR 1214 to FM 455 that will be taken off TxDOT system upon completion of the reconstruction process is complete for the new FM 428 alignment,

Now, therefore, be it resolved that the Collin County Commissioners Court, does hereby authenticates its support of the realignment and expansion of FM 428 to tie into SH 289 in lieu of FM 455.
