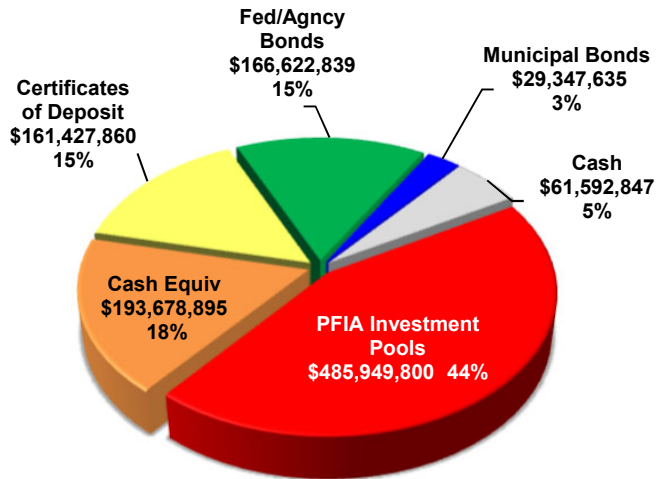

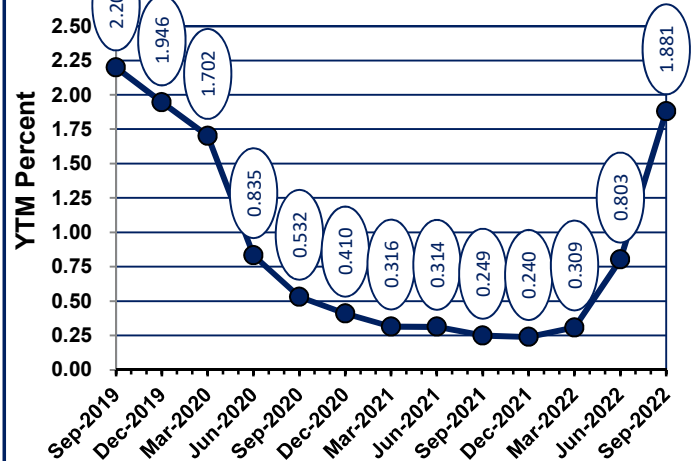

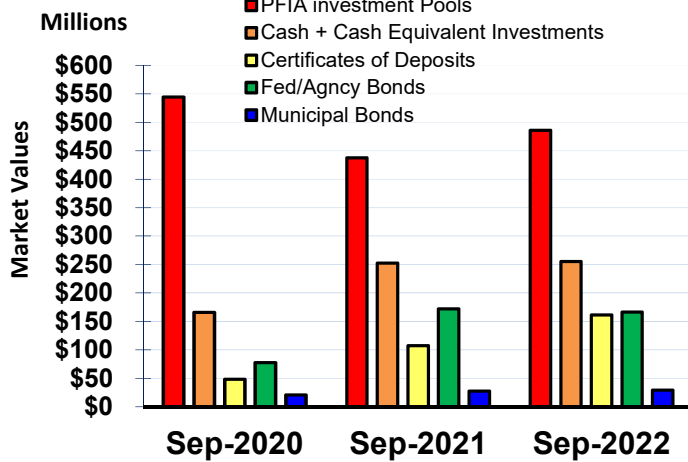
Portfolio Composition by Type



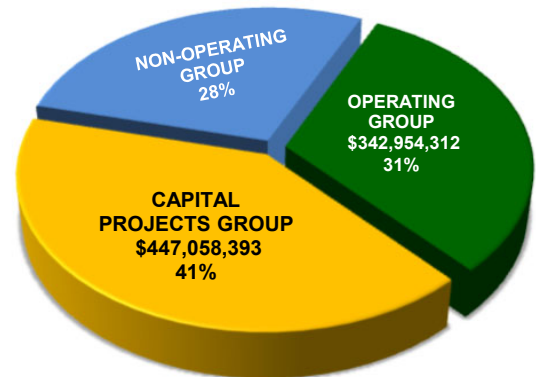
**Portfolio Weighted YTM
3 Year Trend**



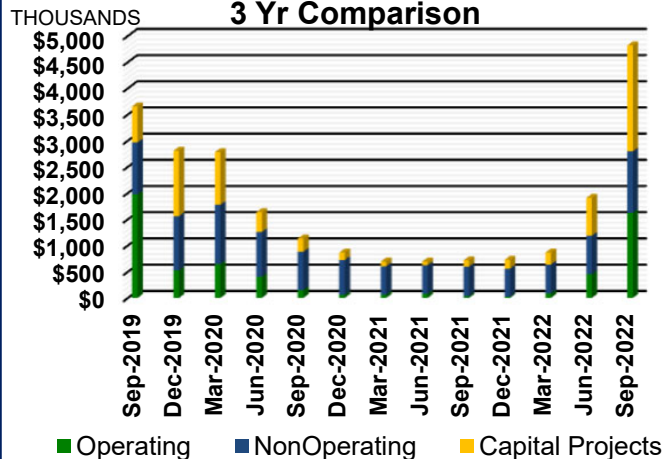
**Portfolio Position by Type
3 Yr Comparison**



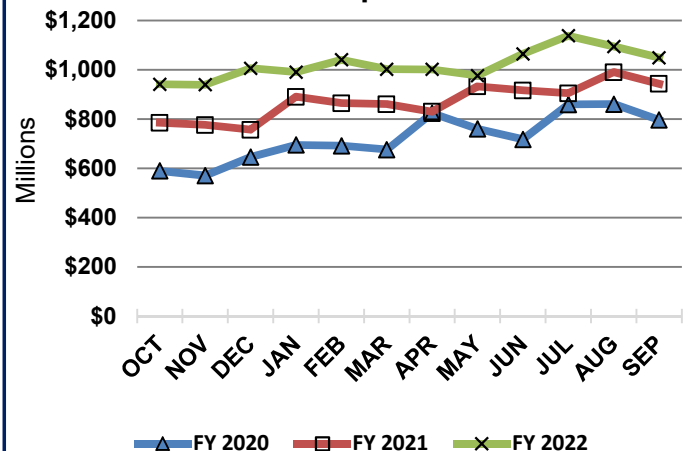
**Portfolio Composition by

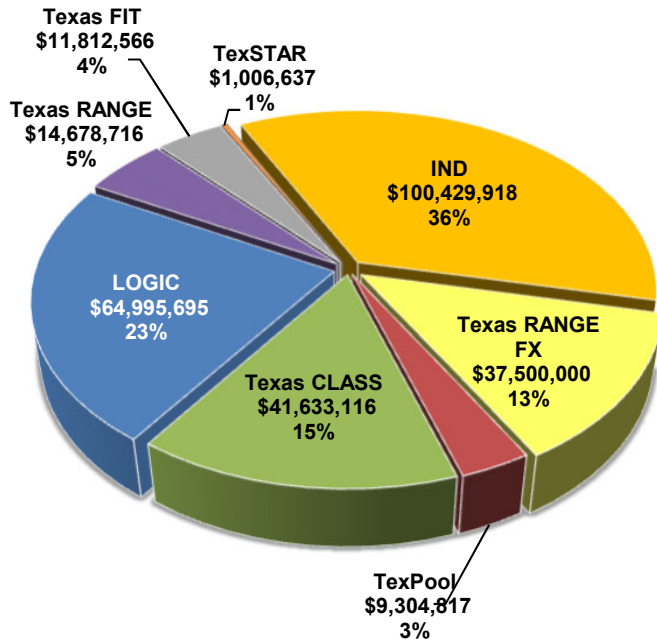

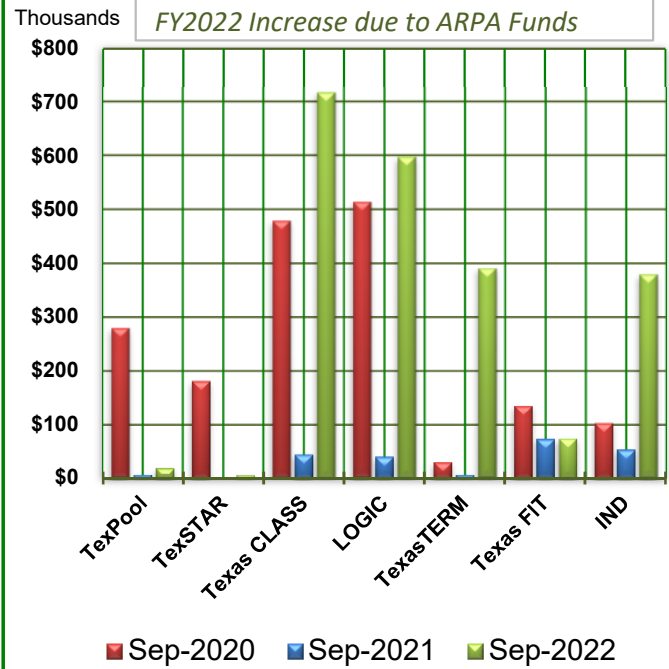

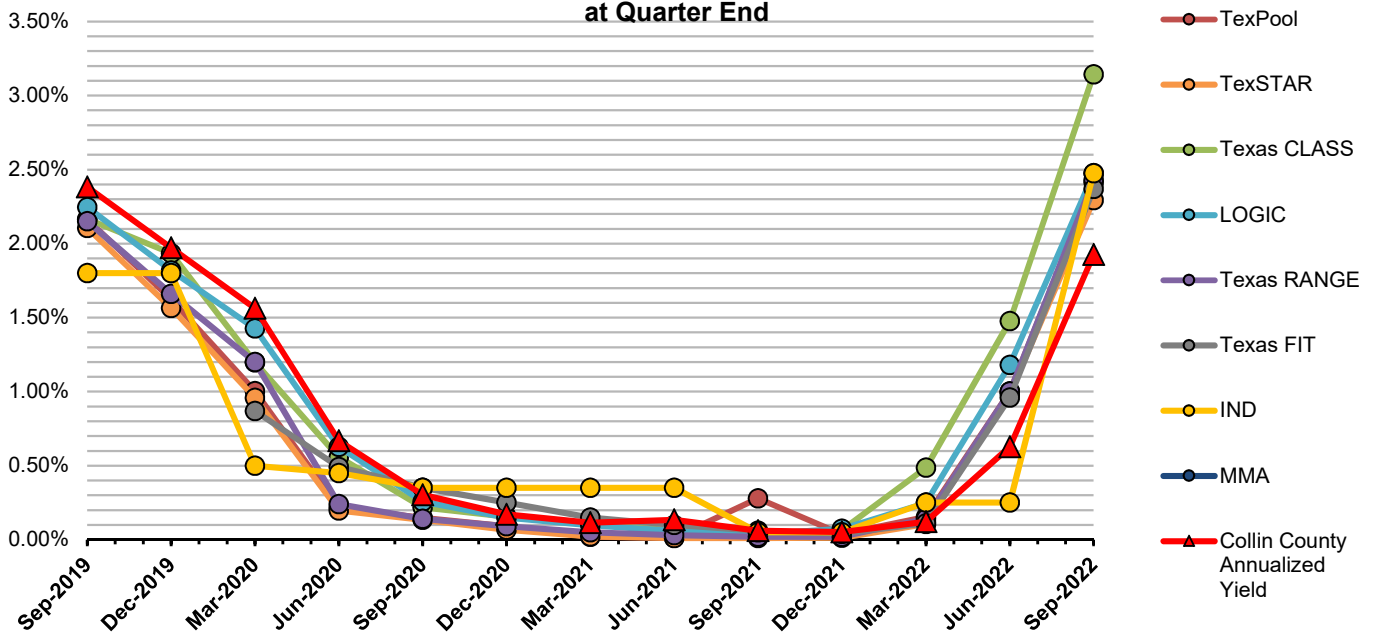
**Operating Investments

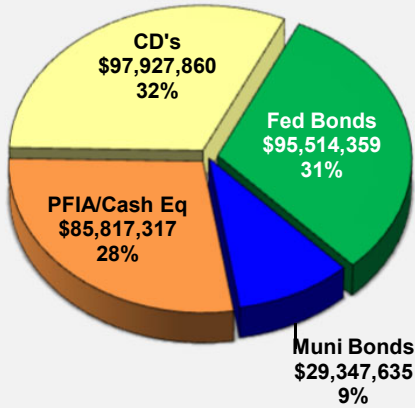

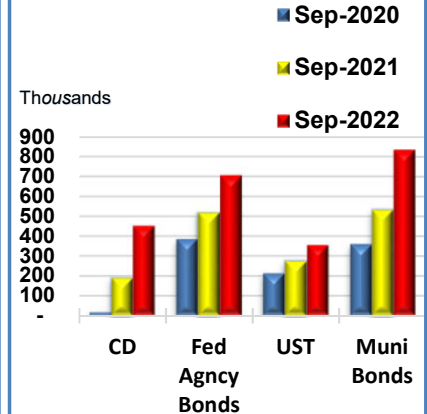
Non-Operating Investments by Type



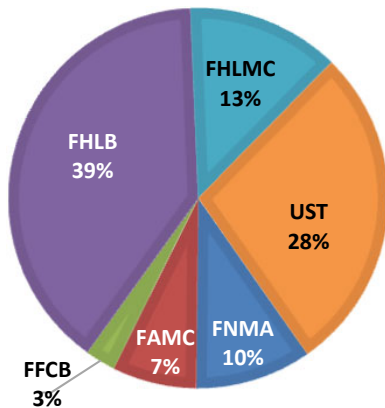
Non-Operating Bond Purchases YTM Versus US Treasury



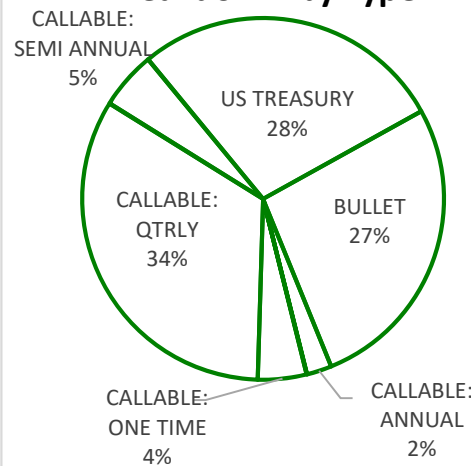
Non-Operating YTD Interest Earnings



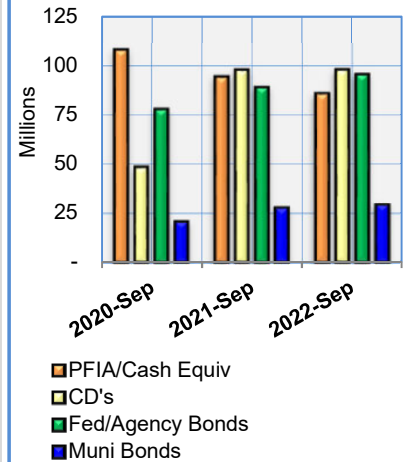
Federal Agency Bonds



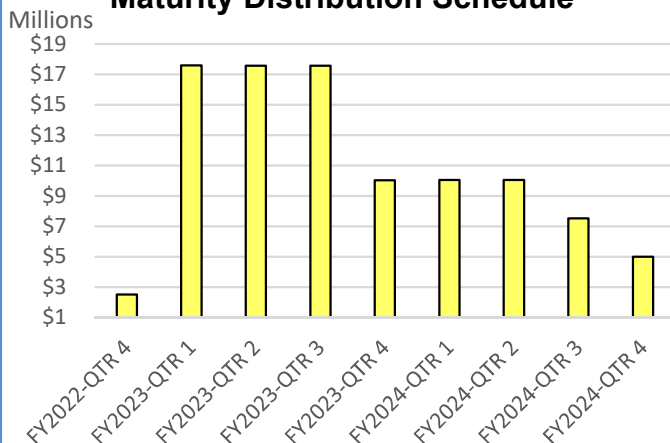
Federal Agency Bonds Breakdown by Type



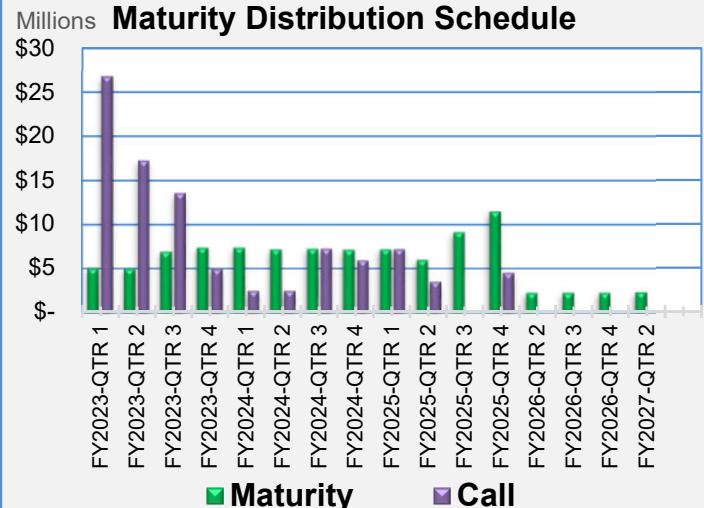
Non-Operating Investments Three Year Comparison as of Quarter End

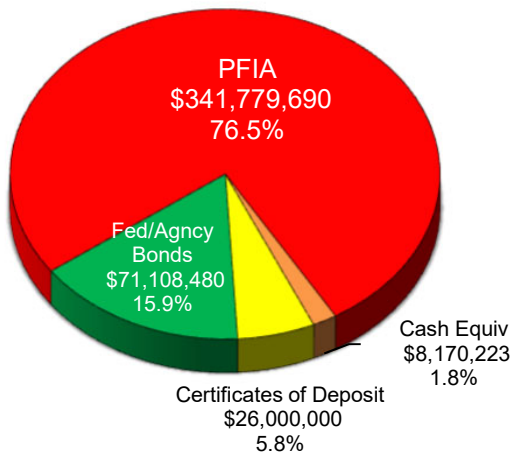

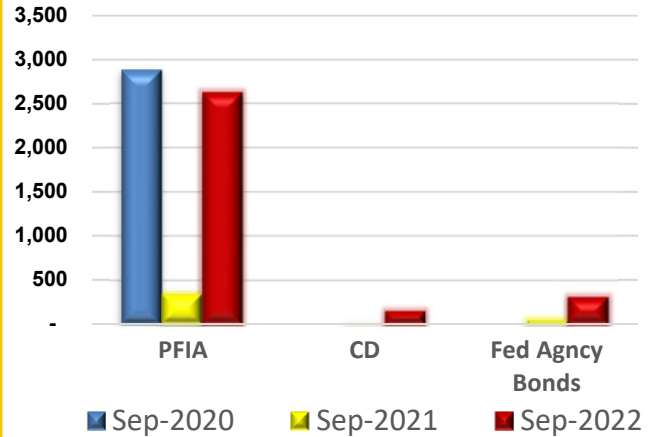

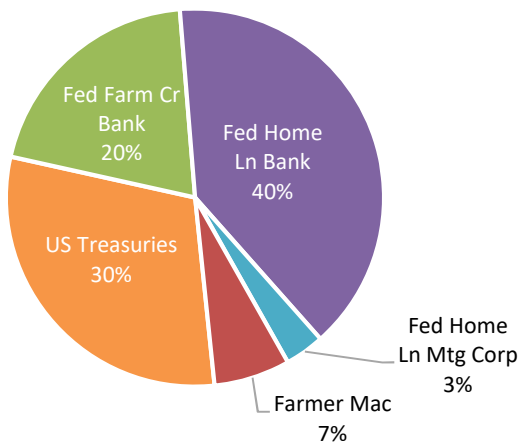
**Capital Projects
Investments by SecurityType**



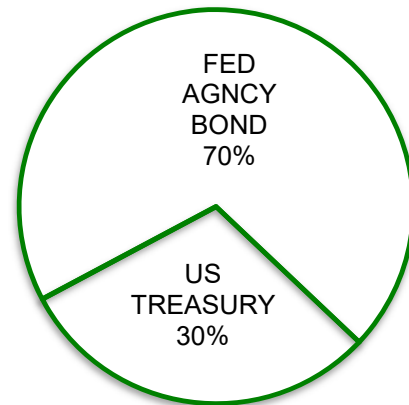
**Capital Projects
YTD Interest Earnings**



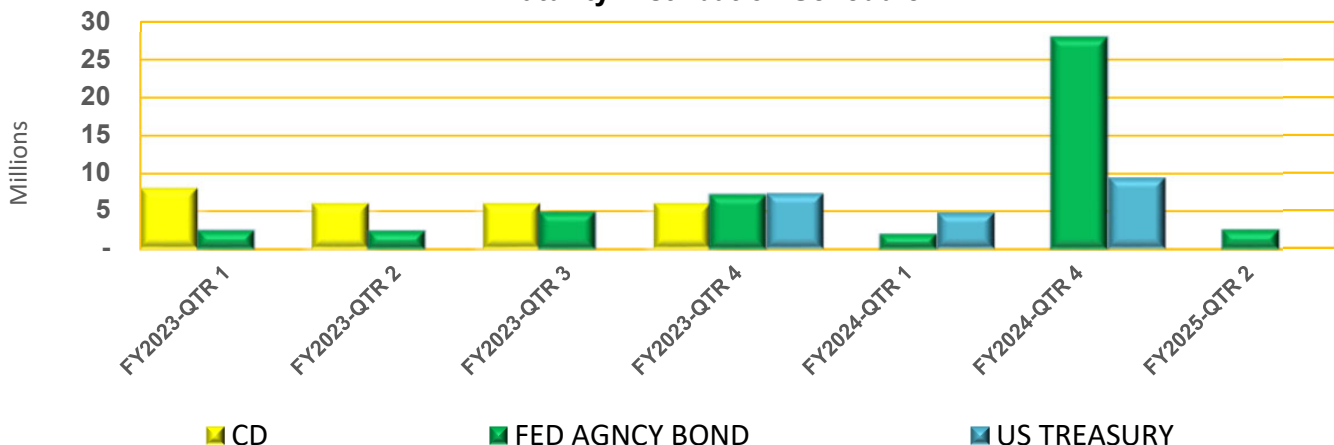
**Federal Agency Bonds

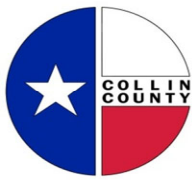
