Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for funding to develop, enhance, or expand programs for girls in the juvenile justice system and girls at risk of becoming involved in the juvenile justice system. This program furthers DOJ's mission to reduce recidivism and improve public safety by helping jurisdictions more effectively reinvest resources that empower girls in the juvenile justice system and at-risk girls with the skills needed to lower engagement in risky behaviors, further their own personal development, and/or facilitate successful reintegration of girls involved in the juvenile justice system.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource</u> <u>Guide</u>, which provides additional information for applicants to prepare and submit applications to OJP for funding. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

OJJDP's guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will <u>Treat Children as Children</u>; <u>Serve Children at Home, With Their Families, in their Communities;</u> and <u>Open Up</u> <u>Opportunities for System-Involved Youth</u>. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP will provide funding to communities to support girls age 17 and younger who are at risk of involvement and/or are involved in the juvenile justice system. Funding will support communities to develop, enhance, or expand early intervention programs and/or treatment services for girls involved in the juvenile justice system.

Specific Information

Girls involved in the juvenile justice system face a host of challenges and have a critical need for services. Many girls involved in the juvenile justice system experience trauma and other adverse childhood experiences such as physical and sexual abuse; poverty; and racial, ethnic, and gender biases, which can lead to their involvement in the juvenile justice system. They also experience family dysfunction, mental health and substance use problems, high-risk sexual behaviors, and school problems. Research shows that girls involved in the juvenile justice system need prevention and early intervention programs that are approached in a multisystemic, trauma-informed, and gender-specific manner.[1]

Research also recommends improving training for judges, law enforcement, and juvenile justice staff to better serve girls. Improving system and programmatic responses for girls requires engaging a broad array of stakeholders. These include state juvenile justice specialists, state advisory groups, girls' alliances and coalitions, advocates, law enforcement officers, prosecutors, juvenile defenders, probation officers, victim service providers, researchers, and most importantly, girls and their families.

OJJDP believes that the needs of girls must be addressed in a developmentally appropriate manner. This means recognizing a girl's pathway into the juvenile justice system and limiting juvenile justice involvement to only those who pose a risk to public safety. Then, for those very few girls, it means reducing reliance on secure placement; implementing evidence-based programs; and creating healthy social environments with family, peers, community, social institutions, and society.

Goals, Objectives, and Deliverables

Goals

The goal of this program is to reduce risk factors and promote protective factors for girls who come in contact with the juvenile justice system, and place them on a path toward success, stability, and long-term contribution to society.

For the purposes of this solicitation, "at-risk girls" and "girls involved in the juvenile justice system" refer to girls age 17 and younger who are in need of guidance, treatment, or rehabilitation due to unhealthy behaviors (i.e., substance use, sexual exploitation, gang involvement, truancy, running away, delinquency) or have been arrested or referred for intake to a public agency (state, Tribal, city, or county) legally responsible for handling

criminal offenses.

Objectives

An applicant should address all the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

Funded sites under this initiative will work to accomplish the following objectives:

- Increase protective factors to prevent further delinquent behavior by girls involved in proposed programs funded under this solicitation.
- Improve juvenile justice system responses for girls in contact with the juvenile justice system.

Deliverables

An applicant should address all the deliverables in the program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

Applicants should discuss how they will implement the following deliverables in their application that will be delivered as a result of this program:

- Develop and implement direct service programs for girls involved in the juvenile justice system to reduce reoffending OR enhance or expand existing early intervention programs to meet the specific needs of girls at risk or involved in the juvenile justice system.
- Work collaboratively with the OJJDP training and technical assistance provider to implement a planning process, as needed, and identify and implement evidenceinformed practices to reduce risk factors and promote protective factors for girls who come in contact with the juvenile justice system.
- Participate in an annual grantee meeting hosted by the OJJDP training and technical assistance provider.

Applications submitted by nongovernmental organizations must have a partnership via a draft or fully executed memorandum of understanding (MOU) or analogous document with public juvenile justice agencies at the local or state level. This will ensure close collaboration around referrals for those girls involved in the juvenile justice system and who are eligible for services provided by the proposed project. A draft or fully executed MOU or analogous document must be included as an attachment with the submitted application to be considered for funding. OJJDP expects these programs to be based upon best practices and may include a variety of services (i.e., in-home services, screening/ assessment, educational, counseling, etc.).

Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this priority consideration, applicants must include in their application a plan that describes how the applicant will incorporate these values and priorities into their program design.

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the <u>OJP Grant Application Resource Guide</u> for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. Tables, charts, and graphs included in the program narrative 30-page limit should be no smaller than 10-point font. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Applicants should briefly describe the nature and scope of the problem that the program will address. The applicant should use data and research to provide evidence that the problem exists, demonstrate the size and scope of the problem, document the effects of the problem on the target population and the larger community, and describe what resources are needed to address the problem. Any data or research referenced in the narrative should include information about the source of the data and/or a citation.
